

Senate Resolution 592

#### A RESOLUTION

1 Honoring the life and memory of Dr. Joe Wilber; and for other purposes.

2 WHEREAS, the State of Georgia mourns the loss of one of its most distinguished citizens  
3 with the passing of Dr. Joe Wilber on April 3, 2011; and

4 WHEREAS, Dr. Wilber was born in Rochester, New York, and dedicated his life to helping  
5 others through his work in the field of medicine; and

6 WHEREAS, he served as a guardian of this nation's freedom and liberty with the United  
7 States Army, valiantly and courageously protecting his fellow Americans during World War  
8 II; and

9 WHEREAS, Dr. Wilber earned a medical degree from Harvard Medical School and  
10 completed residencies at Boston City Hospital and Grady Memorial Hospital; and

11 WHEREAS, he served as a local private practitioner in internal medicine before embarking  
12 on his distinguished public health career; and

13 WHEREAS, Dr. Wilber established the nation's first public hypertension program and  
14 Georgia's state diabetes program and ran programs for the Georgia Division of Public Health  
15 to curb tuberculosis, sexual diseases, flu epidemics, rabies, meningitis, AIDS, and food  
16 poisoning outbreaks; and

17 WHEREAS, as head of the infectious disease program in the 1980's, Dr. Wilber tackled the  
18 emerging AIDS crisis by setting up HIV clinics, lobbying for state money to treat those  
19 living with HIV, and helped in the establishment of Jerusalem House, an AIDS hospice; and

20 WHEREAS, Dr. Wilber served as president of the Georgia Heart Association, was a clinical  
21 professor of medicine at the Emory University School of Medicine, and served as medical  
22 director of the Georgia International Life Insurance Company; and

23 WHEREAS, he helped found the Good Samaritan Health & Wellness Center in Jasper, a free  
24 clinic where he volunteered in retirement several days a week, treating everything from  
25 diabetes to hypertension; and

26 WHEREAS, Dr. Wilber was united in love and marriage to Dr. Patricia Bryan Wilber for 58  
27 wonderful years; was blessed with four remarkable children, Joe Wilber, John Wilber, Bryan  
28 Wilber, and Dr. Martha Wilber; and was the proud grandfather of seven grandchildren; and

29 WHEREAS, he gave inspiration to many through his high ideals, morals, and deep concern  
30 for his fellow citizens, and the devotion, patience, and understanding he demonstrated to his  
31 family and friends were admired by others; and

32 WHEREAS, he was a person of magnanimous strengths with an unimpeachable reputation  
33 for integrity, intelligence, fairness, and kindness and, by the example he made of his life, he  
34 made this world a better place in which to live; and

35 WHEREAS, a compassionate and generous man, Dr. Wilber will long be remembered for  
36 his love of family and friendship, and this loyal husband, father, grandfather, and friend will  
37 be missed by all who had the great fortune of knowing him.

38 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body  
39 join in honoring the life and memory of Dr. Joe Wilber and express their deepest and most  
40 sincere regret at his passing.
