- 14 helped lead her to win the 2011 NCAA Elite 88 Award for highest grade point average of all

- 17 All-American of the Year, Big East Scholar-Athlete of the Year in 2010 and 2011, and
- 18 CoSIDA Academic All-American in 2009, and is a three-time WBCA Wade Trophy honoree
- 19 and four-time WBCA State Farm First Team All-American; and
- 20 WHEREAS, Ms. Moore has won the Naismith Trophy, Associated Press Player of the Year
- 21 Award, the John R. Wooden Award, the Lowe's Senior CLASS Award for Women's
- 22 Basketball, and USBWA Player of the Year Award; and
