

House Bill 592 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the board of commissioners of Gwinnett County, approved
2 January 31, 1968 (Ga. L. 1968, p. 4658), as amended, particularly by an Act approved March
3 20, 1990 (Ga. L. 1990, p. 3998), so as to repeal provisions relating to public dissemination
4 of amounts expended by the county for professional services; to provide for related matters;
5 to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 An Act creating the board of commissioners of Gwinnett County, approved January 31, 1968
9 (Ga. L. 1968, p. 4658), as amended, particularly by an Act approved March 20, 1990 (Ga.
10 L. 1990, p. 3998), is amended by repealing subsection (d) of Section 7 which reads as
11 follows:

12 "(d)(1) As used in this subsection, the term:

13 (A) 'Person' means an individual, a corporation, a partnership, a business trust, an
14 association, a firm, or any other legal entity.

15 (B) 'Professional services' includes but is not limited to the practice of architecture, the
16 practice of professional engineering, the practice of land surveying, the practice of
17 landscape architecture, the practice of law, and consultant or professional study
18 services. The term 'professional services' shall not include indigent defense services;
19 medical services; educational and recreational instruction; counseling services; banking
20 services; court reporting; medical examiner services; arbitration; investigation services,
21 expert witnesses for criminal proceedings, or other professional services associated with
22 judicial proceedings; veterinarian services; language translation services; funeral and
23 burial services; drug testing; and preemployment psychological screenings. The term
24 'professional services' is not intended to include such services provided by county
25 employees as part of their job duties, but rather is intended to include only such services
26 provided on a nonemployee contractual basis.

27 (2) The board of commissioners shall prepare monthly and make available for public
28 dissemination in the county legal organ and such other media as the board shall deem
29 appropriate an itemized account of all funds expended for professional services, except
30 those services excluded under subparagraph (B) of paragraph (1) of this subsection. The
31 account shall state the name of the person receiving county funds, the amount so
32 received, and the professional service provided. If a vendor receives more than one
33 payment during a month for the same type of professional service, then it shall be
34 sufficient to publish the total of such payments."

35 **SECTION 2.**

36 All laws and parts of laws in conflict with this Act are repealed.
