## A BILL TO BE ENTITLED AN ACT

- 1 To amend Chapter 26 of Title 43 of the Official Code of Georgia Annotated, relating to
- 2 nurses, so as to revise the definitions of "approved nursing education programs" for
- 3 registered professional nurses and licensed practical nurses; to provide for related matters;
- 4 to provide for an effective date; to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

6	SECTION 1.
7	Chapter 26 of Title 43 of the Official Code of Georgia Annotated, relating to nurses, is
8	amended by revising paragraph (1.2) of Code Section 43-26-3, relating to definitions relative
9	to registered professional nurses, as follows:
0	"(1.2) 'Approved nursing education program' located in this state means a nursing
1	education program approved by the board as meeting criteria established by the board.
12	An 'approved nursing education program' located outside this state means a nursing
13	education program that the board has determined to meet criteria similar to and not less
4	stringent than criteria established by the board for nursing education programs located in
15	this state. In order to be approved by the board, a nursing education program must be one

26 (E)(D) A nonprofit postsecondary institution of higher education that is a four-year 27 institution that is not accredited in accordance with subparagraph (C) of this paragraph, 28 but whose curriculum has been determined by the board to meet criteria similar to and 29 not less stringent than criteria established by the board for other approved nursing 30 education programs."

31 **SECTION 2.** 

Said chapter is further amended by revising paragraph (1.1) of Code Section 43-26-32, 32 33

- relating to definitions relative to licensed practical nurses, as follows:
- 34 "(1.1) 'Approved nursing education program' located in this state means a nursing
- 35 education program approved by the board as meeting criteria established by the board.
- 36 An 'approved nursing education program' located outside this state means a nursing
- 37 education program that the board has determined to meet criteria similar to and not less
- stringent than criteria established by the board <u>for nursing education programs located in</u> 38
- 39 this state. In order to be approved by the board, a nursing education program must be one
- that is offered by: 40
- (A) A unit of the University System of Georgia accredited by the Commission on 41
- 42 Colleges of the Southern Association of Colleges and Schools;
- 43 (B) An institution of the Technical College System of Georgia;
- 44 (C) A nonprofit postsecondary institution of higher education that is accredited by a

**SECTION 3.** 53

- 54 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 55 without such approval.

All laws and parts of laws in conflict with this Act are repealed. 57
