A BILL TO BE ENTITLED AN ACT

To amend Chapter 2 of Title 20 of the Official Code of Georgia Annotated, relating to 1 2 elementary and secondary education, so as to delete obsolete, unused, and unnecessary provisions; to clarify a provision relating to eligibility for enrollment; to eliminate a deadline 3 for annual performance evaluations; to clarify the legal status of regional educational service 4 5 agencies; to provide that declarations of intent and attendance records for home study programs are submitted to the Department of Education rather than local school systems; to 6 revise provisions for purposes of conformity; to provide for related matters; to repeal 7 conflicting laws; and for other purposes. 8

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

Chapter 2 of Title 20 of the Official Code of Georgia Annotated, relating to elementary and
secondary education, is amended by revising Code Section 20-2-5, relating to oaths of

members of the State Board of Education, board meetings, and the chairperson, as follows:
"20-2-5.

The members of the State Board of Education shall take an oath of office for the faithful 15 16 performance of their duties and the oath of allegiance to the federal and state Constitutions. They shall meet at the state capital in the Department of Education or at such place in the 17 18 capital as may be designated by the Governor for that purpose. The state board shall meet 19 quarterly in regular session at such time as it may by regulation provide and may hold additional meetings at the call of the chairperson, provided that upon the written request 20 of a majority of the members of the state board, the State School Superintendent shall call 21 22 a meeting at any time."

125 (a) The State Board of Education shall adopt and prescribe all rules, regulations, and policies required by this article and such other rules, regulations, and policies as may be 126 reasonably necessary or advisable for proper implementation, enforcement, and carrying 127 out of this article and other public school laws and for assuring a more economical and 128 efficient operation of the public schools of this state or any phase of public elementary and 129 secondary education in this state. The state board shall establish and enforce standards for 130 operation of all public elementary and secondary schools and local units of administration 131 in this state so as to assure, to the greatest extent possible, equal and quality educational 132 programs, curricula, offerings, opportunities, and facilities for all of Georgia's children and 133 134 youth and for economy and efficiency in administration and operation of public schools 135 and local school systems throughout the state. The state board shall have the power to 136 perform all duties and to exercise all responsibilities vested in it by provisions of law for 137 the improvement of public elementary and secondary education in this state, including 138 actions designed to improve teacher and school effectiveness through research and 139 demonstration projects. The state board shall have the power to take such actions as it deems necessary to ensure that the citizens have full awareness and knowledge relative to 140 141 the costs, quality, and performance of the public elementary and secondary schools of this 142 state. All rules, regulations, policies, and standards adopted or prescribed by the state board 143 in carrying out this article and other school laws shall, if not in conflict therewith, have the full force and effect of law. 144

(b) The State Board of Education is authorized, after a reasonable attempt at consultation
with the State School Superintendent, to organize and reorganize the Department of
Education and the various offices, divisions, sections, and units thereof and to prescribe the
duties, functions, and operations of each at such times and in such manner as the state
board may deem necessary or desirable for the more economical or effective organization,
administration, or functioning of the department."

(4) The home study program shall provide a basic academic educational program which
includes, but is not limited to, reading, language arts, mathematics, social studies, and
science;

(5) The home study program must provide instruction each 12 months to home study
students equivalent to 180 school days of education with each school day consisting of
at least four and one-half school hours unless the child is physically unable to comply
with the rule provided for in this paragraph;

- 272 (6) Attendance records for the home study program shall be kept and shall be submitted to the Department of Education, in accordance with department guidelines at the end of 273 each month to the school superintendent of the local school district in which the home 274 275 study program is located. Attendance records and reports shall not be used for any purpose except providing necessary attendance information, except with the permission 276 of the parent or guardian of a child, pursuant to the subpoena of a court of competent 277 278 jurisdiction, or for verification of attendance by the Department of Public Safety for the 279 purposes set forth in subsection (a.1) of Code Section 40-5-22;
- (7) Students in home study programs shall be subject to an appropriate nationally
 standardized testing program administered in consultation with a person trained in the
 administration and interpretation of norm reference tests to evaluate their educational
 progress at least every three years beginning at the end of the third grade and records of

such tests and scores shall be retained but shall not be required to be submitted to publiceducational authorities; and

- (8) The home study program instructor shall write an annual progress assessment report
 which shall include the instructor's individualized assessment of the student's academic
 progress in each of the subject areas specified in paragraph (4) of this subsection, and
- such progress reports shall be retained by the parent, parents, or guardian of children in
- the home study program for a period of at least three years."
