

Senate Resolution 669

A RESOLUTION

1 Commending the Boy Scouts of America program and recognizing March 21, 2012, as Boy
2 Scouts of America Day at the state capitol; and for other purposes.

3 WHEREAS, the Boy Scouts of America, a volunteer organization, was incorporated by
4 Chicago publisher William D. Boyce on February 8, 1910, after learning of the Scouting
5 movement during a visit to London; and

6 WHEREAS, on June 21, 1910, a group of 34 national representatives met, developed
7 organization plans, and opened a temporary national headquarters for the program in New
8 York; and

9 WHEREAS, the purpose of the Boy Scouts of America is to teach America's youth
10 patriotism, courage, self-reliance, and kindred values; and

11 WHEREAS, the Boy Scouts of America has and continues to live out its commitment to
12 helping millions of youth succeed by providing the support, friendship, and mentoring
13 necessary to live a happy and fulfilling life; and

14 WHEREAS, by 1912, Boy Scouts were enrolled in every state, and in 1916, the United
15 States Congress granted the Boy Scouts of America a federal charter; and

16 WHEREAS, each council requires a Scout to perform at least 12 hours of community service
17 annually, totaling more than 30 million community service hours each year; and

18 WHEREAS, there have now been more than 111 million members of Scouting, and the
19 organization presented the two millionth Eagle Scout award in 2009; and

20 WHEREAS, more than 1 million adult volunteer leaders selflessly serve young people in
21 their communities through organizations chartered by the Boy Scouts of America, often
22 neither receiving nor seeking the thanks of the public; and

23 WHEREAS, the Boy Scouts of America endeavors to develop United States citizens who are
24 physically, mentally, and emotionally fit; have a high degree of self-reliance as evidenced
25 in such qualities as initiative, courage, and resourcefulness; have personal values based on
26 religious concepts; have the desire and skills to help others and understand the principles of
27 the United States' social, economic, and governmental systems; take pride in their American
28 heritage and understand our nation's role in the world; have a keen respect for the basic rights
29 of all people; and are prepared to participate in and give leadership to American society; and

30 WHEREAS, it is abundantly fitting and proper that this amazing organization be
31 appropriately recognized.

32 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
33 commend the Boy Scouts of America program for improving the lives of countless young
34 men and inspiring all Americans to be better citizens and recognize March 21, 2012, as Boy
35 Scouts of America Day at the state capitol.

36 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
37 to transmit an appropriate copy of this resolution to the Boys Scouts of America program.
