A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act entitled "An Act to provide education districts for the Calhoun County
- 2 Board of Education," approved April 13, 1992 (Ga. L. 1992, p. 6119), so as to provide for
- 3 new education districts; to provide for the continuation in office of current office holders; to
- 4 provide for the submission of this Act to the United States Department of Justice for
- 5 preclearance; to provide for effective dates; to repeal conflicting laws; and for other
- 6 purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

- 9 An Act entitled "An Act to provide education districts for the Calhoun County Board of
- 10 Education," approved April 13, 1992 (Ga. L. 1992, p. 6119), is amended by revising
- 11 Section 1 as follows:
- 12 "SECTION 1.
- 13 (a) For the purpose of electing members of the Board of Education of Calhoun County, the
- 14 Calhoun County School District shall be divided into five education districts. Such districts
- shall be and correspond to those five numbered districts described in and attached to and
- made a part of this Act and further identified as 'Plan: calhouncesb-2012 Plan Type: local
- 17 Administrator: calhoun User: bak'.
- 18 (b)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall
- mean and describe the same geographical boundaries as provided in the report of the
- 20 Bureau of the Census for the United States decennial census of 2010 for the State of
- 21 Georgia.
- 22 (2) The separate numeric designations in a district description which are underneath a
- VTD heading shall mean and describe individual Blocks within a VTD as provided in the
- report of the Bureau of the Census for the United States decennial census of 2010 for the
- 25 State of Georgia. Any part of the Calhoun County School District which is not included

in any such district described in that attachment shall be included within that district

- 27 contiguous to such part which contains the least population according to the United States
- decennial census of 2010 for the State of Georgia.
- 29 (3) Any part of the Calhoun County School District which is described in that attachment
- 30 as being in a particular district shall nevertheless not be included within such district if such
- 31 part is not contiguous to such district. Such noncontiguous part shall instead be included
- within that district contiguous to such part which contains the least population according
- to the United States decennial census of 2010 for the State of Georgia.
- 34 (4) Except as otherwise provided in the description of any education district, whenever the
- description of such district refers to a named city, it shall mean the geographical boundaries
- of that city as shown on the census map for the United States decennial census of 2010 for
- 37 the State of Georgia."

38 SECTION 2.

- 39 The Board of Education of Calhoun County which existed on December 31, 2012, is
- 40 continued in existence but on and after January 1, 2013, shall be constituted as provided in
- 41 this Act. The Board of Education of Calhoun County so continued and constituted shall
- 42 continue to have the powers, duties, rights, obligations, and liabilities of that board as existed
- 43 immediately prior to January 1, 2013.

44 SECTION 3.

- 45 It shall be the duty of the Board of Education of Calhoun County to require the attorney
- 46 therefor to submit this Act for approval pursuant to Section 5 of the federal Voting Rights
- 47 Act of 1965, as amended.

48 SECTION 4.

- 49 The provisions of this section and Section 1 of this Act relating to and necessary for the
- 50 regular election in 2012 of members of the Board of Education of Calhoun County shall
- 51 become effective upon its approval by the Governor or upon its becoming effective without
- such approval; and this Act shall otherwise become effective January 1, 2013.

53 **SECTION 5.**

54 All laws and parts of laws in conflict with this Act are repealed.
