

House Bill 767

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for reapportionment or redistricting of the districts from and by
2 which members of the board of education of Johnson County are elected, approved March
3 1, 2004 (Ga. L. 2004, p. 3506), as amended, particularly by an Act approved May 11, 2009
4 (Ga. L. 2009, p. 4225), so as to describe new election districts; to provide for submission of
5 this Act for preclearance under the federal Voting Rights Act of 1965, as amended; to
6 provide for related matters; to provide an effective date; to repeal conflicting laws; and for
7 other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 An Act providing for reapportionment or redistricting of the districts from and by which
11 members of the board of education of Johnson County are elected, approved March 1, 2004
12 (Ga. L. 2004, p. 3506), as amended, particularly by an Act approved May 11, 2009 (Ga. L.
13 2009, p. 4225), is amended by revising Section 3 as follows:

14 "SECTION 3.

15 (a) Those members of the Board of Education of Johnson County who are serving as such
16 on June 30, 2012, and any person selected to fill a vacancy in any such office shall continue
17 to serve as such members until the regular expiration of their respective terms of office and
18 upon the election and qualification of their respective successors. The Board of Education
19 of Johnson County shall consist of five members elected from commissioner districts
20 described in subsection (b) of this section.

21 (b) For the purpose of electing members of the Board of Education of Johnson County, the
22 Johnson County School District is divided into five districts. Such districts shall be and
23 correspond to those five numbered districts described in and attached to and made a part
24 of this Act and further identified as 'Plan: johnsonccsb-2012 Plan Type: Local
25 Administrator: Johnson User: bak'.

26 (c) For the purposes of such plan:

27 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
28 provided in the report of the Bureau of the Census for the United States decennial census
29 of 2010 for the State of Georgia. The separate numeric designations in a district
30 description which are underneath a 'VTD' heading shall mean and describe individual
31 Blocks within a VTD as provided in the report of the Bureau of the Census for the United
32 States decennial census of 2010 for the State of Georgia; and

33 (2) Except as otherwise provided in the description of any district, whenever the
34 description of any district refers to a named city, it shall mean the geographical
35 boundaries of that city as shown on the census maps for the United States decennial
36 census of 2010 for the State of Georgia.

37 (3) Any part of the Johnson County School District which is not included in any district
38 described in subsection (a) of this section shall be included within that district contiguous
39 to such part which contains the least population according to the United States decennial
40 census of 2010 for the State of Georgia."

41 **SECTION 2.**

42 The Board of Education of Johnson County shall through its legal counsel cause this Act to
43 be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965, as
44 amended, no later than 45 days after the date on which this Act is approved by the Governor
45 or otherwise becomes law without such approval.

46 **SECTION 3.**

47 For the purpose of conducting elections in 2012, this Act shall become effective upon its
48 approval by the Governor or upon its becoming law without such approval. For all other
49 purposes, this Act shall become effective on July 1, 2012.

50 **SECTION 4.**

51 All laws and parts of laws in conflict with this Act are repealed.
