

House Bill 773

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act relating to the Board of Education of Newton County, approved March 31,  
2 1967 (Ga. L. 1967, p. 2405), as amended, particularly by an Act approved May 30, 2003  
3 (Ga. L. 2003, p. 3778), so as to reconstitute the board of education; to change the description  
4 of the education districts; to provide for definitions and inclusions; to provide for  
5 continuation in office of current members; to provide for election and terms of office of  
6 subsequent members; to provide for submission of this Act for approval under Section 5 of  
7 the federal Voting Rights Act of 1965, as amended; to provide for automatic repeal under  
8 certain circumstances; to repeal conflicting laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 **SECTION 1.**

11 An Act relating to the Board of Education of Newton County, approved March 31, 1967  
12 (Ga. L. 1967, p. 2405), as amended, particularly by an Act approved May 30, 2003  
13 (Ga. L. 2003, p. 3778), is amended by striking Section 1 and inserting in lieu thereof the  
14 following:

15 "SECTION 1.

16 (a) The Board of Education of Newton County which existed immediately prior to the  
17 effective date of this Act is continued in existence but on and after the effective date of this  
18 Act shall be constituted as provided in this Act. The Board of Education of Newton  
19 County so continued and constituted, sometimes referred to in this Act as the 'board,' shall  
20 continue to have the powers, duties, rights, obligations, and liabilities of that board as  
21 existed immediately prior to the effective date of this Act.

22 (b) Those members of the Board of Education of Newton County who are serving as such  
23 immediately prior to the effective date of this Act, and any person selected to fill a vacancy  
24 in any such office, shall continue to serve as such members until the regular expiration of  
25 their respective terms of office and upon the election and qualification of their respective  
26 successors. On and after the effective date of this Act, the Board of Education of Newton

27 County shall consist of five members all of whom shall be elected from education districts  
28 described in subsection (c) of this section.

29 (c) For purposes of electing members of the board of education, the Newton County  
30 School District is divided into five education districts. One member of the board shall be  
31 elected from each such district. The five education districts shall be and correspond to  
32 those five numbered districts described in and attached to and made a part of this Act and  
33 further identified as Plan: newtonccsb-2012 Plan Type: Local Administrator: newton  
34 County User: bak.

35 (d)(1) For the purposes of such plan:

36 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
37 provided in the report of the Bureau of the Census for the United States decennial  
38 census of 2010 for the State of Georgia. The separate numeric designations in a district  
39 description which are underneath a 'VTD' heading shall mean and describe individual  
40 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
41 United States decennial census of 2010 for the State of Georgia; and

42 (B) Except as otherwise provided in the description of any district, whenever the  
43 description of any district refers to a named city, it shall mean the geographical  
44 boundaries of that city as shown on the census maps for the United States decennial  
45 census of 2010 for the State of Georgia.

46 (2) Any part of Newton County which is not included in any district described in  
47 subsection (c) of this section shall be included within that district contiguous to such part  
48 which contains the least population according to the United States decennial census of  
49 2010 for the State of Georgia.

50 (3) Any part of Newton County which is described in subsection (c) of this section as  
51 being included in a particular district shall nevertheless not be included within such  
52 district if such part is not contiguous to such district. Such noncontiguous part shall  
53 instead be included within that district contiguous to such part which contains the least  
54 population according to the United States decennial census of 2010 for the State of  
55 Georgia.

56 (e) The members of the reconstituted Board of Education of Newton County shall be  
57 elected as provided in this subsection. The first members from Education Districts 1, 3,  
58 and 5 shall be elected at the general election on the Tuesday next following the first  
59 Monday in November, 2014. Those members of the board elected thereto from Education  
60 Districts 1, 3, and 5 in 2014 shall take office the first day of January immediately following  
61 that election and shall serve for initial terms of office which expire December 31, 2018, and  
62 upon the election and qualification of their respective successors. The first members from  
63 Education Districts 2 and 4 shall be elected at the general election on the Tuesday next

64 following the first Monday in November, 2012. Those members of the board elected  
65 thereto from Education Districts 2 and 4 in 2012 shall take office the first day of January  
66 immediately following that election and shall serve for initial terms of office which expire  
67 December 31, 2016, and upon the election and qualification of their respective successors.  
68 Those and all future successors to members of the board whose terms of office are to expire  
69 shall be elected at the time of the state-wide general election immediately preceding the  
70 expiration of such terms, shall take office the first day of January immediately following  
71 that election, and shall serve for terms of office of four years each. Members of the board  
72 shall serve for the terms of office specified therefor in this subsection and until their  
73 respective successors are elected and qualified.

74 (f) Education Districts 1 through 5, as they exist immediately prior to the effective date of  
75 this Act, shall continue to be designated as Education Districts 1 through 5, respectively,  
76 but as newly described under this Act, and on and after the effective date of this Act, such  
77 members of the board serving from those former education districts shall be deemed to be  
78 serving from and representing their respective districts as newly described under this Act."

79 **SECTION 2.**

80 The Board of Education of Newton County shall through its legal counsel cause this Act to  
81 be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965, as  
82 amended, no later than 45 days after the date on which this Act is approved by the Governor  
83 or otherwise becomes law without such approval.

84 **SECTION 3.**

85 If, as of the first date upon which candidates may begin qualifying for the general primary  
86 in 2012, implementation of this Act is not permissible under the federal Voting Rights Act  
87 of 1965, as amended, then as of such date this Act shall be void and stand repealed in its  
88 entirety.

89 **SECTION 4.**

90 All laws and parts of laws in conflict with this Act are repealed.
