

House Bill 813

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the Board of Commissioners of Douglas County, approved
2 February 15, 1952 (Ga. L. 1952, p. 2703), as amended, particularly by an Act approved April
3 25, 2002 (Ga. L. 2002, p. 4494), so as to reapportion the commissioner districts; to define
4 certain terms; to provide for submission of this Act for preclearance under the federal Voting
5 Rights Act of 1965, as amended; to provide for effective dates; to repeal conflicting laws;
6 and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating the Board of Commissioners of Douglas County, approved February 15,
10 1952 (Ga. L. 1952, p. 2703), as amended, particularly by an Act approved April 25, 2002
11 (Ga. L. 2002, p. 4494), is amended by striking Section 3 and inserting in its place a new
12 Section 3 to read as follows:

13 "SECTION 3.

14 (a) For purposes of electing members of the board of commissioners, other than the
15 chairperson, Douglas County is divided into four commissioner districts. One member of
16 the board shall be elected from each such district. The four commissioner districts shall be
17 and correspond to those four numbered districts described in and attached to and made a part
18 of this Act and further identified as "Plan: douglascc-2012 Plan Type: Local Administrator:
19 Douglas Co. User: bak".

20 (b)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall
21 mean and describe the same geographical boundaries as provided in the report of the
22 Bureau of the Census for the United States decennial census of 2010 for the State of
23 Georgia.

24 (2) The separate numeric designations in a district description which are underneath a
25 VTD heading shall mean and describe individual Blocks within a VTD as provided in the
26 report of the Bureau of the Census for the United States decennial census of 2010 for the

27 State of Georgia. Any part of Douglas County which is not included in any such district
28 described in that attachment shall be included within that district contiguous to such part
29 which contains the least population according to the United States decennial census of
30 2010 for the State of Georgia.

31 (3) Any part of Douglas County which is described in that attachment as being in a
32 particular district shall nevertheless not be included within such district if such part is not
33 contiguous to such district. Such noncontiguous part shall instead be included within that
34 district contiguous to such part which contains the least population according to the
35 United States decennial census of 2010 for the State of Georgia.

36 (4) Except as otherwise provided in the description of any commissioner district,
37 whenever the description of such district refers to a named city, it shall mean the
38 geographical boundaries of that city as shown on the census map for the United States
39 decennial census of 2010 for the State of Georgia.

40 (c) Commissioner Districts 1, 2, 3, and 4 as they exist immediately prior to the effective date
41 of this Act shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
42 respectively, but as newly described under this Act, and on and after the effective date of this
43 Act, such members of the board serving from those former commissioner districts shall be
44 deemed to be serving from and representing their respective districts as newly described
45 under this Act."

46 **SECTION 2.**

47 Said Act is further amended by repealing the attachment thereto containing the former
48 descriptions of commissioner districts which is identified as "Plan Name:douglasccwk2 Plan
49 Type: Local User:staff Administrator:Douglas."

50 **SECTION 3.**

51 It is the purpose of this Act to reapportion the districts from which members of the Board of
52 Commissioners of Douglas County are to be elected in the November, 2012, general election
53 and in subsequent general elections, and this Act results from changes in population based
54 on the United States decennial census of 2010. It is not the intention of the General Assembly
55 to affect the membership of current members of the board, their terms of office, or the
56 manner in which their successors shall be elected, and such matters shall remain as provided
57 by law on the effective date of this Act until otherwise amended by law, except to the extent
58 of reapportioning the districts represented by such members.

59 **SECTION 4.**

60 The Board of Commissioners of Douglas County shall through its legal counsel cause this
61 Act to be submitted for preclearance under the federal Voting Rights Act of 1965, as
62 amended; and such submission shall be made to the United States Department of Justice or
63 filed with the appropriate court no later than 45 days after the date on which this Act is
64 approved by the Governor or otherwise becomes law without such approval.

65 **SECTION 5.**

66 This section and Section 4 of this Act and those provisions of this Act necessary for the
67 election of members of the Board of Commissioners of Douglas County in 2012 shall
68 become effective upon the approval of this Act by the Governor or upon its becoming law
69 without such approval. The remaining provisions of this Act shall become effective
70 January 1, 2013.

71 **SECTION 6.**

72 All laws and parts of laws in conflict with this Act are repealed.
