

House Bill 702 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing a board of education of Troup County, approved January 1, 1986  
2 (Ga. L. 1986, p. 3515), as amended, particularly by an Act approved March 18, 2002 (Ga.  
3 L. 2002, p. 3600), so as to change the description of the education districts; to provide for  
4 definitions and inclusions; to provide for continuation in office of current members; to  
5 provide for submission of this Act for approval under the federal Voting Rights Act of 1965,  
6 as amended; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 SECTION 1.

9 An Act providing a board of education of Troup County, approved January 1, 1986 (Ga. L.  
10 1986, p. 3515), as amended, particularly by an Act approved March 18, 2002 (Ga. L. 2002,  
11 p. 3600), is amended by revising Section 1 as follows:

12 "SECTION 1.

13 (a) For purposes of electing members of the board of education, the Troup County School  
14 District is divided into seven education districts. One member of the board shall be elected  
15 from each such district. The seven education districts shall be and correspond to those  
16 seven numbered districts described in and attached to and made a part of this Act and  
17 further identified as Plan: troupsb-2012 Plan Type: local Administrator: troupsb User: bak.

18 (b) For the purposes of such plan:

19 (1) The term 'VTD' shall mean and describe the same geographical boundaries as  
20 provided in the report of the Bureau of the Census for the United States decennial census  
21 of 2010 for the State of Georgia. The separate numeric designations in a district  
22 description which are underneath a 'VTD' heading shall mean and describe individual  
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the United  
24 States decennial census of 2010 for the State of Georgia;

25 (2) Except as otherwise provided in the description of any district, whenever the  
26 description of any district refers to a named city, it shall mean the geographical  
27 boundaries of that city as shown on the census maps for the United States decennial  
28 census of 2010 for the State of Georgia;

29 (3) Any part of the Troup County School District which is not included in any district  
30 described in subsection (b) of this section shall be included within that district contiguous  
31 to such part which contains the least population according to the United States decennial  
32 census of 2010 for the State of Georgia; and

33 (4) Any part of the Troup County School District which is described in subsection (b)  
34 of this section as being included in a particular district shall nevertheless not be included  
35 within such district if such part is not contiguous to such district. Such noncontiguous  
36 part shall instead be included within that district contiguous to such part which contains  
37 the least population according to the United States decennial census of 2010 for the State  
38 of Georgia."

39 **SECTION 2.**

40 The Board of Education of Troup County which existed on December 31, 2012, is continued  
41 in existence but on and after January 1, 2013, shall be constituted as provided in this Act.  
42 The Board of Education of Troup County so continued and constituted, sometimes referred  
43 to in this Act as the "board," shall continue to have the powers, duties, rights, obligations, and  
44 liabilities of that board as existed immediately prior to January 1, 2013.

45 **SECTION 3.**

46 The Board of Education of Troup County shall through its legal counsel cause this Act to be  
47 submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965, as  
48 amended, no later than 45 days after the date on which this Act is approved by the Governor  
49 or otherwise becomes law without such approval.

50 **SECTION 4.**

51 This section and Section 1 of this Act and those provisions of this Act necessary for the  
52 election of members of the Board of Education of Troup County in 2012 shall become  
53 effective upon the approval of this Act by the Governor or upon its becoming law without  
54 such approval. The remaining provisions of this Act shall become effective January 1, 2013.

55 **SECTION 5.**

56 All laws and parts of laws in conflict with this Act are repealed.
