A BILL TO BE ENTITLED
AN ACT

1 To amend an Act reconstituting the Board of Education of Warren County, approved
2 February 4, 1993 (Ga. L. 1993, p. 3651), as amended, particularly by an Act approved
3 March 10, 2008 (Ga. L. 2008, p. 3531), so as to change the description of the education
4 districts; to provide for definitions and inclusions; to provide for the continuation in office
5 of current members; to provide for the submission of this Act for preclearance pursuant to
6 Section 5 of the federal Voting Rights Act of 1965, as amended; to provide for related
7 matters; to repeal conflicting laws; and for other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 An Act reconstituting the Board of Education of Warren County, approved February 4, 1993
11 (Ga. L. 1993, p. 3651), as amended, particularly by an Act approved March 10, 2008
12 (Ga. L. 2008, p. 3531), is amended by revising subsections (b) and (c) of Section 2 as
13 follows:

14 "(b) For the purpose of electing members of the board of education, the Warren County
15 School District is divided into five education districts. One member of the board shall be
16 elected from each such district. The districts shall be and correspond to those five
17 numbered districts described in and attached to and made a part of this Act and further
18 identified as 'Plan: warrensb-2012 Plan Type: Local Administrator: Warren SB User: SE'.

19 (c)(1) For the purposes of such plan:

20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
21 provided in the report of the Bureau of the Census for the United States decennial
22 census of 2010 for the State of Georgia. The separate numeric designations in a district
23 description which are underneath a VTD heading shall mean and describe individual
24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
25 United States decennial census of 2010 for the State of Georgia; and

26 (B) Except as otherwise provided in the description of any district, whenever the
27 description of any district refers to a named city, it shall mean the geographical
28 boundaries of that city as shown on the census maps for the United States decennial
29 census of 2010 for the State of Georgia.

30 (2) Any part of the Warren County School District which is not included in any district
31 described in subsection (b) of this section shall be included within that district contiguous
32 to such part which contains the least population according to the United States decennial
33 census of 2010 for the State of Georgia.

34 (3) Any part of the Warren County School District which is described in subsection (b)
35 of this section as being included in a particular district shall nevertheless not be included
36 within such district if such part is not contiguous to such district. Such noncontiguous
37 part shall instead be included within that district contiguous to such part which contains
38 the least population according to the United States decennial census of 2010 for the State
39 of Georgia."

40 **SECTION 2.**

41 (a) Those members of the Board of Education of Warren County who are serving as such
42 on the effective date of this Act and any person selected to fill a vacancy in any such office
43 shall continue to serve as such members until the regular expiration of their respective terms
44 of office and upon the election and qualification of their respective successors.

45 (b) Education Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date
46 of this Act, shall continue to be designated as Education Districts 1, 2, 3, 4, and 5,
47 respectively, but as newly described under this Act, and on and after the effective date of this
48 Act, such members of the board serving from those former education districts shall be
49 deemed to be serving from and representing their respective districts as newly described
50 under this Act.

51 **SECTION 3.**

52 The Board of Education of Warren County shall through its legal counsel cause this Act to
53 be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965, as
54 amended, not later than 45 days after the date on which this Act is approved by the Governor
55 or otherwise becomes law without such approval.

56 **SECTION 4.**

57 All laws and parts of laws in conflict with this Act are repealed.
