

House Bill 1009

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating and establishing a board of commissioners of Worth County,  
2 approved August 15, 1904 (Ga. L. 1904, p. 842), as amended, particularly by an Act  
3 approved April 25, 2002 (Ga. L. 2002, p. 4861), so as to reapportion the commissioner  
4 districts; to define certain terms; to provide for members currently serving; to provide for the  
5 submission of this Act to the United States Department of Justice; to provide for related  
6 matters; to provide effective dates; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act creating and establishing a board of commissioners of Worth County, approved  
10 August 15, 1904 (Ga. L. 1904, p. 842), as amended, particularly by an Act approved April  
11 25, 2002 (Ga. L. 2002, p. 4861), is amended by striking subsections (a) and (b) of Section  
12 2 and inserting in lieu thereof the following:

13 "(a) For purposes of electing the chairperson and members of the board of commissioners  
14 of Worth County, there shall be five commissioner districts to be designated Commissioner  
15 Districts 1 through 5, and one commissioner shall be elected from each district.  
16 Commissioner District 5 shall consist of the entirety of Worth County. For the purpose of  
17 electing the four remaining commissioners, Worth County shall be divided into four  
18 commissioner districts which shall be and correspond to those four numbered districts  
19 described in and attached to and made a part of this Act and further identified as 'Plan:  
20 worthccsb-2012 Plan Type: Local Administrator: Worth User: bak'.

21 (b) When used in such attachment, the terms 'VTD' shall mean and describe the same  
22 geographical boundaries as provided in the report of the Bureau of the Census for the  
23 United States decennial census of 2010 for the State of Georgia. The separate numeric  
24 designations in a district description which are underneath a 'VTD' heading shall mean and  
25 describe individual Blocks within a VTD as provided in the report of the Bureau of the  
26 Census for the United States decennial census of 2010 for the State of Georgia. Any part

27 of Worth County which is not included in any such district described in that attachment  
28 shall be included within that district contiguous to such part which contains the least  
29 population according to the United States decennial census of 2010 for the State of  
30 Georgia. Any part of Worth County which is described in that attachment as being in a  
31 particular district shall nevertheless not be included within such district if such part is not  
32 contiguous to such district. Such noncontiguous part shall instead be included within that  
33 district contiguous to such part which contains the least population according to the United  
34 States decennial census of 2010 for the State of Georgia. Except as otherwise provided in  
35 the description of any commissioner district, whenever the description of such district  
36 refers to a named city, it shall mean the geographical boundaries of that city as shown on  
37 the census map for the United States decennial census of 2010 for the State of Georgia."

**SECTION 2.**

39 It is the purpose of this Act to reapportion the districts from which members of the board of  
40 commissioners of Worth County are to be elected in the November, 2012, general election  
41 and in subsequent general elections, and this Act results from changes in population based  
42 on the United States decennial census of 2010. It is not the intention of the General  
43 Assembly to affect the membership of current members of the board, their terms of office,  
44 or the manner in which their successors shall be elected, and such matters shall remain as  
45 provided by law on the effective date of this Act until otherwise amended by law, except to  
46 the extent of reapportioning the districts represented by such members.

**SECTION 3.**

48 The board of commissioners of Worth County shall through its legal counsel cause this Act  
49 to be submitted for preclearance under the federal Voting Rights Act of 1965, as amended;  
50 and such submission shall be made to the United States Department of Justice or filed with  
51 the appropriate court no later than 45 days after the date on which this Act is approved by the  
52 Governor or otherwise becomes law without such approval.

**SECTION 4.**

54 The provisions of this Act relating to and necessary for the regular election in 2012 of  
55 members of the board of commissioners of Worth County shall become effective upon its  
56 approval by the Governor or upon its becoming effective without such approval; and this Act  
57 shall otherwise become effective January 1, 2013.

**SECTION 5.**

59 All laws and parts of laws in conflict with this Act are repealed.
