AS PASSED SENATE

**A BILL TO BE ENTITLED
AN ACT**

1 To amend an Act reconstituting the Board of Education of Ware County, approved
2 September 18, 1991 (Ga. L. 1991, Ex. Sess., p. 445), as amended, so as to change the
3 description of the education districts; to provide for definitions and inclusions; to provide for
4 continuation in office of current members; to provide for submission of this Act for
5 preclearance under Section 5 of the federal Voting Rights Act of 1965, as amended; to
6 provide for related matters; to repeal conflicting laws; and for other purposes.

7 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

8 **SECTION 1.**

9 An Act reconstituting the Board of Education of Ware County, approved September 18, 1991
10 (Ga. L. 1991, Ex. Sess., p. 445), as amended, is amended by revising Section 2 as follows:

11 "SECTION 2.

12 (a) The existing Board of Education of Ware County is continued, but shall be constituted
13 as provided in this Act. On and after January 1, 2013, that board shall consist of seven
14 elected members all of whom shall be elected from education districts described in
15 subsection (b) of this section.

16 (b) For purposes of electing members of the board of education, the Ware County School
17 District is divided into seven education districts. One member of the board shall be elected
18 from each such district. The seven education districts shall be and correspond to those
19 seven numbered districts described in and attached to and made a part of this Act and
20 further identified as 'Plan: waresb-2012 Plan Type: Local Administrator: Ware
21 User: Gina'.

22 (c)(1) For the purposes of such plan:

23 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
24 provided in the report of the Bureau of the Census for the United States decennial
25 census of 2010 for the State of Georgia. The separate numeric designations in a district
26 description which are underneath a VTD heading shall mean and describe individual

27 Blocks within a VTD as provided in the report of the Bureau of the Census for the
28 United States decennial census of 2010 for the State of Georgia; and

29 (B) Except as otherwise provided in the description of any district, whenever the
30 description of any district refers to a named city, it shall mean the geographical
31 boundaries of that city as shown on the census maps for the United States decennial
32 census of 2010 for the State of Georgia.

33 (2) Any part of the Ware County School District which is not included in any district
34 described in subsection (b) of this section shall be included within that district contiguous
35 to such part which contains the least population according to the United States decennial
36 census of 2010 for the State of Georgia.

37 (3) Any part of the Ware County School District which is described in subsection (b) of
38 this section as being included in a particular district shall nevertheless not be included
39 within such district if such part is not contiguous to such district. Such noncontiguous
40 part shall instead be included within that district contiguous to such part which contains
41 the least population according to the United States decennial census of 2010 for the State
42 of Georgia.”

43 **SECTION 2.**

44 (a) Those members of the Board of Education of Ware County who are serving as such on
45 the effective date of this Act and any person selected to fill a vacancy in any such office shall
46 continue to serve as such members until the regular expiration of their respective terms of
47 office and upon the election and qualification of their respective successors.

48 (b) Education Districts 1, 2, 3, 4, 5, 6, and 7 as they exist immediately prior to the effective
49 date of this Act, shall continue to be designated as Education Districts 1, 2, 3, 4, 5, 6, and 7,
50 respectively, but as newly described under this Act, and on and after the effective date of this
51 Act, such members of the board serving from those former education districts shall be
52 deemed to be serving from and representing their respective districts as newly described
53 under this Act.

54 **SECTION 3.**

55 The Board of Education of Ware County shall through its legal counsel cause this Act to be
56 submitted for preclearance under the federal Voting Rights Act of 1965, as amended, not
57 later than 45 days after the date on which this Act is approved by the Governor or otherwise
58 becomes law without such approval.

59 **SECTION 4.**

60 All laws and parts of laws in conflict with this Act are repealed.
