

House Bill 1038

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act creating the Board of Commissioners of Madison County, approved  
2 March 27, 1965 (Ga. L. 1965, p. 2667), as amended, so as to revise the districts for the  
3 election of members of the board of commissioners; to provide for definitions and inclusions;  
4 to provide for method of election; to provide for renumbering of certain districts; to provide  
5 for submission of this Act for preclearance pursuant to Section 5 of the federal Voting Rights  
6 Act of 1965, as amended; to provide for related matters; to provide for a contingent  
7 automatic repeal; to repeal conflicting laws; and for other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 An Act creating the Board of Commissioners of Madison County, approved March 27, 1965  
11 (Ga. L. 1965, p. 2667), as amended, is amended by revising Section 2 to read as follows:

12 **"SECTION 2.**

13 (a) For the purpose of electing the members of the board of commissioners, Madison  
14 County shall be divided into five commissioner districts. The districts shall be and  
15 correspond to those five numbered districts described in and attached to and made a part  
16 of this Act and further identified as 'Plan: madisonccsb-2012 Plan Type: Local  
17 Administrator: Madison Co User: Gina'.

18 (b) For purposes of such plan:

19 (1) The term 'VTD' shall mean and describe the same geographical boundaries as  
20 provided in the report of the Bureau of the Census for the United States decennial census  
21 of 2010 for the State of Georgia. The separate numeric designations in a district  
22 description which are underneath a 'VTD' heading shall mean and describe individual  
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the United  
24 States decennial census of 2010 for the State of Georgia.

25 (2) Except as otherwise provided in the description of any district, whenever the  
 26 description of such district refers to a named city, it shall mean the geographical  
 27 boundaries of that city as shown on the census map for the United States decennial census  
 28 of 2010 for the State of Georgia.

29 (c) Any part of Madison County which is not included in any such district described in  
 30 subsection (b) of this section shall be included within that district contiguous to such part  
 31 which contains the least population according to the United States decennial census of 2010  
 32 for the State of Georgia.

33 (d) Any part of Madison County which is described in subsection (b) of this section as  
 34 being in a particular district shall nevertheless not be included within such district if such  
 35 part is not contiguous to such district. Such noncontiguous part shall instead be included  
 36 within that district contiguous to such part which contains the least population according  
 37 to the United States decennial census of 2010 for the State of Georgia.

38 (e) On and after the effective date of this Act, members of the board serving from former  
 39 Commissioner Districts 1, 3, and 5 shall be deemed to be serving from and representing  
 40 their respective districts as newly described under this section; the member of the board  
 41 serving from former Commissioner District 2 shall be deemed to be serving from  
 42 Commissioner District 4 as newly described under this section; and the member from  
 43 former Commissioner District 4 shall be deemed to be serving from Commissioner District  
 44 2 as newly described in this section."

45 **SECTION 2.**

46 Said Act is further amended by revising Section 3 to read as follows:

47 "SECTION 3.

48 The chairperson and members in office on the effective date of this Act and any person  
 49 selected to fill a vacancy in any such office shall complete the terms to which they were  
 50 elected and until successors are elected and qualified as provided in this Act. At the  
 51 general election in November, 2014, the successors to the members of the board of  
 52 commissioners representing reconstituted Districts 3, 4, and 5 as provided in subsection (b)  
 53 of Section 2 of this Act shall be elected to take office on January 1, 2015, for terms of four  
 54 years. At the general election in November, 2012, the successors to the chairperson and  
 55 members of the board of commissioners representing reconstituted Districts 1 and 2 as  
 56 provided in subsection (b) of Section 2 shall be elected to take office on January 1, 2013,  
 57 for terms of four years. Thereafter, all successors shall be elected at the general election  
 58 immediately preceding the expiration of their terms of office and shall serve terms of terms  
 59 of four years and until their successors are elected and qualified."

60 **SECTION 3.**

61 The governing authority of Madison County shall through its legal counsel cause this Act to  
62 be submitted for approval pursuant to Section 5 of the federal Voting Rights Act of 1965, as  
63 amended, no later than 45 days after the date on which this Act is approved by the Governor  
64 or otherwise becomes law without such approval.

65 **SECTION 4.**

66 If, as of the first date upon which candidates may begin qualifying for the general primary  
67 in 2012, implementation of this Act is not permissible under the federal Voting Rights Act  
68 of 1965, as amended, then as of such date this Act shall be void and stand repealed in its  
69 entirety.

70 **SECTION 5.**

71 All laws and parts of laws in conflict with this Act are repealed.
