A RESOLUTION

1 Honoring the Hugh Hodgson School of Music at the University of Georgia; and for other

2 purposes.

3 WHEREAS, the Hugh Hodgson School of Music has provided the State of Georgia, the 4 United States, and the world with many great performances, teachers, researchers, and 5 scholars in the musical arts; and

6 WHEREAS, Hugh Hodgson, the first professor of music at the University of Georgia and the
7 School of Music's namesake, was appointed in 1928 to establish a department of fine arts and
8 music; and

9 WHEREAS, between 1930 and 1941, the School of Music developed four degree programs

10 in music, including the University of Georgia's first graduate degree in music; and

11 WHEREAS, since Hugh Hodgson's retirement in 1960, the School of Music has been ably

12 served by capable administrators such as Edwin Gerchefski, Robert John, David Ledet, Olin

13 Parker, Ralph Verrastro, Richard Graham, Donald Lowe, and its current director, Dale

14 Monson; and

WHEREAS, in 2005, the School of Music relocated to a new building, and the building andthe program were named in honor of Hugh Hodgson; and

WHEREAS, the Hugh Hodgson School of Music today is the academic home to over 450
undergraduate and graduate students, 65 faculty members, and renowned ensembles,
including its Wind Ensemble, Symphony Orchestra, Hodgson Singers, and Opera Ensemble;

21 WHEREAS, students of Hugh Hodgson School of Music have been invited to play in concert

halls, theaters, and houses of worship across the country and the world; and

- 23 WHEREAS, many alumni of the Hugh Hodgson School of Music today live in the State of
- 24 Georgia and provide this state's youth with the fruits of an education received at the Hugh
- 25 Hodgson School of Music; and
- WHEREAS, it has consistently grown as an institution of performance, pedagogy, andscholarship in music; and
- 28 WHEREAS, it is abundantly fitting that the accomplishments of the students, faculty, staff,
- and alumni of the Hugh Hodgson School of Music be appropriately recognized.
- 30 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
- 31 the members of this body honor and commend the Hugh Hodgson School of Music, its
- 32 faculty, staff, alumni, and its current students for their continuing commitment to the highest
- 33 levels of musical achievement.
