

House Bill 1077

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act reconstituting the Board of Education of Talbot County, approved April 5,  
2 1993 (Ga. L. 1993, p. 4710), as amended, particularly by an Act approved June 4, 2003  
3 (Ga. L. 2003, p. 4697), so as to revise the districts for the election of members of the board  
4 of education; to provide for definitions and inclusions; to provide for submission of this Act  
5 for preclearance pursuant to Section 5 of the federal Voting Rights Act of 1965, as amended;  
6 to provide for related matters; to repeal conflicting laws; and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act reconstituting the Board of Education of Talbot County, approved April 5, 1993  
10 (Ga. L. 1993, p. 4710), as amended, particularly by an Act approved June 4, 2003  
11 (Ga. L. 2003, p. 4697), is amended by revising Section 2 as follows:

12 "SECTION 2.

13 (a) For the purpose of electing members to the Talbot County Board of Education, the  
14 Talbot County School District is divided into five education districts which shall be and  
15 correspond to those five numbered districts described in and attached to and made a part  
16 of this Act and further identified as 'Plan: talbotccsbr1-2012 Plan Type: Local  
17 Administrator: Talbot User: SE'.

18 (b)(1) For the purposes of such plan:

19 (A) The term 'VTD' shall mean and describe the same geographical boundaries as  
20 provided in the report of the Bureau of the Census for the United States decennial  
21 census of 2010 for the State of Georgia. The separate numeric designations in a district  
22 description which are underneath a VTD heading shall mean and describe individual  
23 Blocks within a VTD as provided in the report of the Bureau of the Census for the  
24 United States decennial census of 2010 for the State of Georgia; and

25 (B) Except as otherwise provided in the description of any district, whenever the  
26 description of any district refers to a named city, it shall mean the geographical  
27 boundaries of that city as shown on the census maps for the United States decennial  
28 census of 2010 for the State of Georgia.

29 (2) Any part of Talbot County which is not included in any district described in  
30 subsection (a) of this section shall be included within that district contiguous to such part  
31 which contains the least population according to the United States decennial census of  
32 2010 for the State of Georgia.

33 (3) Any part of Talbot County which is described in subsection (a) of this section as  
34 being included in a particular district shall nevertheless not be included within such  
35 district if such part is not contiguous to such district. Such noncontiguous part shall  
36 instead be included within that district contiguous to such part which contains the least  
37 population according to the United States decennial census of 2010 for the State of  
38 Georgia.

39 (c) The present members of the board of education shall serve for the terms of office for  
40 which they were elected and until their successors are elected and qualified. Education  
41 Districts 1 through 5, as they exist immediately prior to the effective date of this section,  
42 shall continue to be designated as Education Districts 1 through 5, respectively, but as  
43 newly described under this Act; and, on and after the effective date of this section, such  
44 members of the board serving from those former education districts shall be deemed to be  
45 serving from and representing their respective districts as newly described under this Act."

46 **SECTION 2.**

47 The Board of Education of Talbot County shall through its legal counsel cause this Act to be  
48 submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965, as  
49 amended, no later than 45 days after the date on which this Act is approved by the Governor  
50 or otherwise becomes law without such approval.

51 **SECTION 3.**

52 All laws and parts of laws in conflict with this Act are repealed.
