

House Bill 779 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the Board of Education of Pulaski County and consolidating  
2 and restating the laws relative thereto, approved April 4, 1991 (Ga. L. 1991, p. 4175), as  
3 amended, particularly by an Act approved April 23, 2002 (Ga. L. 2002, p. 4102), so as to  
4 change the description of the education districts; to provide for definitions and inclusions;  
5 to provide for continuation in office of current members; to provide for election and terms  
6 of office of members; to provide for submission of this Act for approval under the federal  
7 Voting Rights Act of 1965, as amended; to provide for effective dates; to repeal conflicting  
8 laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 style="text-align:center">**SECTION 1.**

11 An Act providing for the Board of Education of Pulaski County and consolidating and  
12 restating the laws relative thereto, approved April 4, 1991 (Ga. L. 1991, p. 4175), as  
13 amended, particularly by an Act approved April 23, 2002 (Ga. L. 2002, p. 4102), is amended  
14 by revising Section 1 as follows:

15 style="text-align:center">"SECTION 1.

16 (a) The Board of Education of Pulaski County shall consist of seven members, all of whom  
17 shall be elected from education districts described in subsection (b) of this section.

18 (b) For purposes of electing members of the board of education, the Pulaski County School  
19 District is divided into seven education districts. One member of the board shall be elected  
20 from each such district. The seven education districts shall be and correspond to those  
21 seven numbered districts described in and attached to and made a part of this Act and  
22 further identified as 'Plan: pulaskisb-2012 Plan Type: Local Administrator: Pulaski SB  
23 User: Gina'.

24 (c)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall  
25 mean and describe the same geographical boundaries as provided in the report of the

26 Bureau of the Census for the United States decennial census of 2010 for the State of  
27 Georgia.

28 (2) The separate numeric designations in a district description which are underneath a  
29 VTD heading shall mean and describe individual Blocks within a VTD as provided in the  
30 report of the Bureau of the Census for the United States decennial census of 2010 for the  
31 State of Georgia. Any part of the Pulaski County School District which is not included  
32 in any such district described in that attachment shall be included within that district  
33 contiguous to such part which contains the least population according to the United States  
34 decennial census of 2010 for the State of Georgia.

35 (3) Any part of the Pulaski County School District which is described in that attachment  
36 as being in a particular district shall nevertheless not be included within such district if  
37 such part is not contiguous to such district. Such noncontiguous part shall instead be  
38 included within that district contiguous to such part which contains the least population  
39 according to the United States decennial census of 2010 for the State of Georgia.

40 (4) Except as otherwise provided in the description of any education district, whenever  
41 the description of such district refers to a named city, it shall mean the geographical  
42 boundaries of that city as shown on the census map for the United States decennial census  
43 of 2010 for the State of Georgia.

44 (d) Each member of the board of education shall be a resident of the respective education  
45 district during the member's term of office. Each person offering for election as a member  
46 of said board shall specify the education district for which the person is offering. Each  
47 member of the board shall be elected by a majority vote of the qualified voters voting  
48 within each respective district. All members of the board shall be elected in nonpartisan  
49 elections without prior nonpartisan primaries as provided for in this Act, and otherwise in  
50 accordance with the provisions of the general election laws of this state."

51 **SECTION 2.**

52 The Board of Education of Pulaski County which existed on December 31, 2012, is  
53 continued in existence but on and after January 1, 2013, shall be constituted as provided in  
54 this Act. The Board of Education of Pulaski County so continued and constituted, sometimes  
55 referred to in this Act as the "board," shall continue to have the powers, duties, rights,  
56 obligations, and liabilities of that board as existed immediately prior to January 1, 2013.

57 **SECTION 3.**

58 It shall be the duty of the Board of Education of Pulaski County to require the attorney  
59 therefor to submit this Act for approval pursuant to Section 5 of the federal Voting Rights  
60 Act of 1965, as amended.

61 **SECTION 4.**

62 The provisions of this section and Section 1 of this Act, relating to and necessary for the  
63 regular election in 2012 of members of the Board of Education of Pulaski County, shall  
64 become effective upon its approval by the Governor or upon its becoming effective without  
65 such approval; and this Act shall otherwise become effective January 1, 2013.

66 **SECTION 5.**

67 All laws and parts of laws in conflict with this Act are repealed.
