

House Bill 750 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act entitled "An Act to increase the number of commissioners of roads and  
2 revenues for the county of Calhoun from three to five," approved August 10, 1908 (Ga. L.  
3 1908, p. 276), as amended, particularly by an Act approved April 13, 1992 (Ga. L. 1992, p.  
4 6123), so as to provide new commissioner districts; to provide for definitions and inclusions;  
5 to provide for continuation in office of current members and the election of their successors;  
6 to provide for submission of this Act for approval under the federal Voting Rights Act of  
7 1965, as amended; to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act entitled "An Act to increase the number of commissioners of roads and revenues for  
11 the county of Calhoun from three to five," approved August 10, 1908 (Ga. L. 1908, p. 276),  
12 as amended, particularly by an Act approved April 13, 1992 (Ga. L. 1992, p. 6123), is  
13 amended by revising Section 1 as follows:

14 "SECTION 1.

- 15 (a) For purposes of electing members of the board of commissioners, Calhoun County is  
16 divided into five commissioner districts. One member of the board shall be elected from  
17 each such district. The five commissioner districts shall be and correspond to those five  
18 numbered districts described in and attached to and made a part of this Act and further  
19 identified as 'Plan: calhouncsb-2012 Plan Type: local Administrator: calhoun User: bak'.  
20 (b) When used in such attachment, the term 'VTD' (voting tabulation district) shall mean  
21 and describe the same geographical boundaries as provided in the report of the Bureau of  
22 the Census for the United States decennial census of 2010 for the State of Georgia.  
23 (c) The separate numeric designations in a district description which are underneath a  
24 VTD heading shall mean and describe individual Blocks within a VTD as provided in the  
25 report of the Bureau of the Census for the United States decennial census of 2010 for the

26 State of Georgia. Any part of Calhoun County which is not included in any such district  
27 described in that attachment shall be included within that district contiguous to such part  
28 which contains the least population according to the United States decennial census of 2010  
29 for the State of Georgia.

30 (d) Any part of Calhoun County which is described in that attachment as being in a  
31 particular district shall nevertheless not be included within such district if such part is not  
32 contiguous to such district. Such noncontiguous part shall instead be included within that  
33 district contiguous to such part which contains the least population according to the United  
34 States decennial census of 2010 for the State of Georgia.

35 (e) Except as otherwise provided in the description of any education district, whenever the  
36 description of such district refers to a named city, it shall mean the geographical boundaries  
37 of that city as shown on the census map for the United States decennial census of 2010 for  
38 the State of Georgia.

39 (f) The Board of Commissioners of Calhoun County which existed on December 31, 2012,  
40 is continued in existence but on and after January 1, 2013, shall be constituted as provided  
41 in this Act. The Board of Commissioners of Calhoun County so continued and constituted,  
42 sometimes referred to in this Act as the 'board,' shall continue to have the powers, duties,  
43 rights, obligations, and liabilities of that board as existed immediately prior to January 1,  
44 2013."

45 **SECTION 2.**

46 It shall be the duty of the Board of Commissioners of Calhoun County to require the attorney  
47 therefor to submit this Act for approval pursuant to Section 5 of the federal Voting Rights  
48 Act of 1965, as amended.

49 **SECTION 3.**

50 The provisions of this section and Section 1 of this Act, relating to and necessary for the  
51 regular election in 2012 of members of the Board of Commissioners of Calhoun County,  
52 shall become effective upon its approval by the Governor or upon its becoming effective  
53 without such approval; and this Act shall otherwise become effective January 1, 2013.

54 **SECTION 4.**

55 All laws and parts of laws in conflict with this Act are repealed.
