

House Bill 768 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act relating to the board of commissioners of Johnson County, approved March
2 27, 1941 (Ga. L. 1941, p. 887), as amended, particularly by an Act approved May 11, 2009
3 (Ga. L. 2009, p. 4229), so as to provide for commissioner districts from and by which
4 members of the board of commissioners are elected; to provide for submission of this Act
5 for preclearance under the federal Voting Rights Act of 1965, as amended; to provide for
6 related matters; to provide an effective date; to repeal conflicting laws; and for other
7 purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:.**

9 **SECTION 1.**

10 An Act relating to the board of commissioners of Johnson County, approved March 27, 1941
11 (Ga. L. 1941, p. 887), as amended, particularly by an Act approved May 11, 2009 (Ga. L.
12 2009, p. 4229), is amended by revising Section 3 as follows:

13 **"SECTION 3.**

14 (a) Those members of the Board of Commissioners of Johnson County who are serving
15 as such on June 30, 2012, and any person selected to fill a vacancy in any such office shall
16 continue to serve as such members until the regular expiration of their respective terms of
17 office and upon the election and qualification of their respective successors. The Board of
18 Commissioners of Johnson County shall consist of five members elected from
19 commissioner districts described in subsection (b) of this section.

20 (b) For the purpose of electing members of the board of commissioners, Johnson County
21 is divided into five districts. Such districts shall be and correspond to those five numbered
22 districts described in and attached to and made a part of this Act and further identified as
23 'Plan: johnsonccsb-2012 Plan Type: Local Administrator: Johnson User: bak'.

24 (c) For the purposes of such plan:

25 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
26 provided in the report of the Bureau of the Census for the United States decennial census
27 of 2010 for the State of Georgia. The separate numeric designations in a district
28 description which are underneath a 'VTD' heading shall mean and describe individual
29 Blocks within a VTD as provided in the report of the Bureau of the Census for the United
30 States decennial census of 2010 for the State of Georgia; and

31 (2) Except as otherwise provided in the description of any district, whenever the
32 description of any district refers to a named city, it shall mean the geographical
33 boundaries of that city as shown on the census maps for the United States decennial
34 census of 2010 for the State of Georgia.

35 (3) Any part of Johnson County which is not included in any district described in
36 subsection (b) of this section shall be included within that district contiguous to such part
37 which contains the least population according to the United States decennial census of
38 2010 for the State of Georgia."

39 **SECTION 2.**

40 The Board of Commissioners of Johnson County shall through its legal counsel cause this
41 Act to be submitted for preclearance under Section 5 of the federal Voting Rights Act of
42 1965, as amended, no later than 45 days after the date on which this Act is approved by the
43 Governor or otherwise becomes law without such approval.

44 **SECTION 3.**

45 For the purpose of conducting elections in 2012, this Act shall become effective upon its
46 approval by the Governor or upon its becoming law without such approval. For all other
47 purposes, this Act shall become effective on July 1, 2012.

48 **SECTION 4.**

49 All laws and parts of laws in conflict with this Act are repealed.
