## A RESOLUTION

- 1 Recognizing and commending Ambassador Andrew Young; and for other purposes.
- 2 WHEREAS, from Ambassador Andrew Young's beginnings as an ordained minister and top  
3 aide to Dr. Martin Luther King, Jr., during the Civil Rights Movement to his current position  
4 as founding principal and chair of GoodWorks International, an organization that embraces  
5 his long-held mission of facilitating economic development in the Caribbean and Africa, his  
6 humanitarian efforts and influence have spanned the globe; and
- 7 WHEREAS, his "good works" have taken him to more than 150 countries, including 48  
8 countries in Africa; and
- 9 WHEREAS, through his leadership, countries throughout the world have created a successful  
10 model that combines religion, education, democracy, and free enterprise in ways that support  
11 the public good; and
- 12 WHEREAS, Ambassador Young has received honorary degrees from more than 60  
13 institutions, including Swarthmore College, Duke University, Emory University, Clark  
14 Atlanta University, the University of Georgia, Morehouse College, and his alma mater,  
15 Howard University; and
- 16 WHEREAS, he has served in the United States Congress and as United States Ambassador  
17 to the United Nations during the Carter Administration; and
- 18 WHEREAS, he has received numerous honors, including the Olympic Order, the highest  
19 award of the Olympic Movement, in 1996 and the Emmy for Lifetime Achievement; and
- 20 WHEREAS, he has served on numerous boards, including the Southern African Enterprise  
21 Development Fund, the Leon H. Sullivan Foundation, the Martin Luther King, Jr. Center for

22 Nonviolent Social Change, Diversapack, Barrick Gold, United Nations, AMC, and Atlanta  
23 Falcons; and

24 WHEREAS, he helped attract 1,100 new businesses and \$70 billion in private investments  
25 and created one million new jobs during his two terms as mayor of Atlanta; and

26 WHEREAS, he is united in love and marriage to Carolyn McClain Young, and together they  
27 are blessed with four remarkable children and six adored grandchildren; and

28 WHEREAS, Ambassador Young is the author of *A Way Out of No Way* and *An Easy Burden*  
29 and co-author of *Walk in My Shoes*; and

30 WHEREAS, the devotion of his time, efforts, and energy to the service of others and his  
31 many achievements are worthy of recognition.

32 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that  
33 the members of this body join to commend Ambassador Andrew Young on his many  
34 contributions to his community, state, and nation.
