AS PASSED SENATE

**A BILL TO BE ENTITLED
AN ACT**

1 To amend Code Section 43-11-52 of the Official Code of Georgia Annotated, relating to the
2 "Georgia Volunteers in Dentistry and Dental Hygiene Act," so as to provide for special
3 licenses for dentists and dental hygienists licensed in other jurisdictions; to amend Code
4 Section 43-11-40 of the Official Code of Georgia Annotated, relating to qualifications of
5 applicants, so as to revise a provision relating to education requirements; to provide for
6 related matters; to repeal conflicting laws; and for other purposes.

7 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

8 **SECTION 1.**

9 Code Section 43-11-52 of the Official Code of Georgia Annotated, relating to the "Georgia
10 Volunteers in Dentistry and Dental Hygiene Act," is amended by revising subsection (b) as
11 follows:

12 "(b) Notwithstanding any other provision of law, the board shall issue a special license to
13 qualifying dentists and dental hygienists under the terms and conditions set forth in this
14 Code section and pursuant to requirements which may be set forth in the rules and
15 regulations of the board. The special license shall only be issued to a person who:

16 (1) Is is retired from the practice of dentistry or dental hygiene and not currently engaged
17 in such practice either full time or part time and has, prior to retirement, maintained full
18 unrestricted licensure in good standing in dentistry or dental hygiene in any state; or
19 (2) Is currently licensed to practice dentistry or dental hygiene in any licensing
20 jurisdiction in the United States and whose license is unrestricted and in good standing.

21 As used in this subsection, the term 'unrestricted' means that no restrictions have been
22 placed on the applicant's license by ~~the~~ any board, no sanctions or disciplinary actions have
23 been imposed by ~~the~~ any board on the applicant, and the applicant is not under probation
24 or suspension by ~~the~~ any board."

25 **SECTION 1A.**

26 Code Section 43-11-40 of the Official Code of Georgia Annotated, relating to qualifications
27 of applicants, is amended by revising subparagraph (a)(1)(A) as follows:

28 "(A) Successful completion at an accredited dental school approved by the board of the
29 last two years of a program ~~leading to~~ and receipt of the doctor of dental surgery
30 (D.D.S.) or doctor of dental medicine (D.M.D.) degree; and"

31 **SECTION 2.**

32 All laws and parts of laws in conflict with this Act are repealed.
