AS PASSED SENATE

**A BILL TO BE ENTITLED
AN ACT**

1 To amend Chapter 13 of Title 16 of the Official Code of Georgia Annotated, relating to
2 controlled substances, so as to change certain provisions relating to Schedule I and V
3 controlled substances; to change certain provisions relating to the definition of "dangerous
4 drug"; to provide an effective date; to repeal conflicting laws; and for other purposes.

5 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

6 **SECTION 1.**

7 Chapter 13 of Title 16 of the Official Code of Georgia Annotated, relating to controlled
8 substances, is amended in Code Section 16-13-25, relating to Schedule I controlled
9 substances, by adding a new subparagraph to paragraph (3) to read as follows:

10 "(GGG) Fluorophenylpiperazine (FPP);"

11 **SECTION 2.**

12 Said chapter is further amended in Code Section 16-13-25, relating to Schedule I controlled
13 substances, by revising paragraph (12) to read as follows:

14 ~~"(12) Any material, compound, mixture, or preparation which contains any quantity of~~
15 ~~the following substances, their salts, isomers (whether optical, positional, or geometric),~~
16 ~~homologues, and salts of isomers and homologues, unless specifically excepted,~~
17 ~~whenever the existence of these salts, isomers, homologues, and salts of isomers and~~

25 ~~(E) 2-(2-Methoxyphenyl)-1-(1-pentylindole-3-yl) ethanone (JWH-250);~~

26 ~~(F) 4-Methoxynaphthalen-1-yl-(1-pentylindole-3-yl) methanone (JWH-081):~~

27 Any of the following compounds, derivatives, their salts, isomers, and salts of isomers,
 28 unless specifically utilized as part of the manufacturing process by a commercial industry
 29 of a substance or material not intended for human ingestion or consumption, as a
 30 prescription administered under medical supervision, or research at a recognized
 31 institution, whenever the existence of these salts, isomers, and salts of isomers is possible
 32 within the specific chemical designation:

33 (A) Naphthoylindoles;

34 (B) Naphthylmethyloindoles;

35 (C) Naphthoylpyrroles;

36 (D) Naphthylideneindenes;

37 (E) Phenylacetylindoles;

38 (F) Cyclohexylphenols;

39 (G) Benzoylindoles;

40 (H) Tricyclic benzopyrans;

41 (I) Adamantoylindoles;

42 (J) Indazole amides;

43 (K) 2,3-Dihydro-5-methyl-3-(4-morpholinylmethyl)pyrrolo[1,2,3-de]-1,4-benzoxazin
 44 -6-yl]-1-naphthalenylmethanone (WIN 55,212-2); or

45 (L) Any compound, unless specifically excepted or listed in this or another schedule,
 46 structurally derived from 2-aminopropan-1-one by substitution at the 1-position with
 47 either phenyl, naphthyl, or thiophene ring systems, whether or not the compound is
 48 further modified in any of the following ways:

49 (i) By substitution in the ring system to any extent with alkyl, alkylendioxy, alkoxy,
 50 haloalkyl, hydroxyl, or halide substitutions, whether or not further substituted in the
 51 ring system;

52 (ii) By substitution at the 3-position with an acyclic alkyl substitution; or

53 (iii) By substitution at the 2-amino nitrogen atom with alkyl, dialkyl, benzyl, or
 54 methoxybenzyl groups, or by inclusion of the 2-amino nitrogen atom in a cyclic
 55 structure."

56 SECTION 3.

57 Said chapter is further amended in Code Section 16-13-29, relating to Schedule V controlled
 58 substances, by deleting "or" at the end of paragraph (4), by replacing the period at the end
 59 of paragraph (5) with "; or", and by adding a new paragraph to read as follows:

60 "(6) Ezogabine."

61 **SECTION 4.**

62 Said chapter is further amended in Code Section 16-13-71, relating to the definition of
 63 dangerous drug, by adding new paragraphs to subsection (b) to read as follows:

 65 "(17.3) Aflibercept;"
 66 "(17.7) Albiraterone;"

93 **SECTION 5.**

94 This Act shall become effective upon its approval by the Governor or upon its becoming law
 95 without such approval.
