## A BILL TO BE ENTITLED AN ACT

- 1 To amend Part 1 of Article 1 of Chapter 18 of Title 43 of the Official Code of Georgia
- 2 Annotated, relating to general provisions relative to funeral directors and establishments,
- 3 embalmers, and crematories, so as to provide for a determination as to whether a dead body
- 4 that has been submitted to a funeral director is that of a deceased veteran; to provide a short
- 5 title; to provide for certain notifications; to allow access to certain veterans' organizations
- 6 under certain circumstances to information about a deceased; to allow certain veterans'
- 7 organizations under certain circumstances to make arrangements for the disposition of the
- 8 cremated remains of a deceased veteran; to provide for immunity; to provide for related
- 9 matters; to provide an effective date; to repeal conflicting laws; and for other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 12 This Act shall be known as and may be cited as the "Disposition of Veterans' Cremated
- 13 Remains Act."

- 14 SECTION 2.
- 15 Part 1 of Article 1 of Chapter 18 of Title 43 of the Official Code of Georgia Annotated,
- 16 relating to general provisions relative to funeral directors and establishments, embalmers, and
- 17 crematories, is amended by adding a new Code section to read as follows:

- 19 (a) As used in this Code section, the term:
- 20 (1) 'Veteran' means a resident of this state who qualifies as a veteran under the rules of
- 21 <u>the United States Department of Veterans Affairs and who was discharged under</u>
- 22 <u>conditions other than dishonorable.</u>
- 23 (2) 'Veterans' organization' means the Department of Veterans Service, the National
- 24 <u>Cemetery Administration's National Cemetery Scheduling Office, or any association or</u>
- 25 <u>other entity organized for the benefit of veterans that has been recognized or chartered</u>

26 by the United States Congress, such as the American Legion, the Legion of Honor, the 27 Patriot Guard, the Missing in America Project, and the Vietnam Veterans of America. 28 (b) The funeral director shall make a reasonable effort to determine whether any dead body 29 submitted for final disposition by cremation is that of a deceased veteran. 30 (c) The funeral director shall, at the time the cremation authorization form is signed: 31 (1) Inquire as to whether the legally authorized person has information or belief as to 32 whether the deceased is a veteran; and 33 (2) Notify the legally authorized person of the responsibilities of the funeral director 34 under this Code section. 35 (d) If the funeral director is unable to determine with certainty whether the deceased was a veteran through an inquiry with the legally authorized agent, then any veterans' 36 37 organization shall be allowed access to all information available from the United States 38 Department of Veterans Affairs regarding the deceased in the possession of the funeral 39 director in charge of the crematory so that any veterans' organization may attempt to 40 determine whether the deceased is a veteran. If any veterans' organization that is allowed 41 access to information pursuant to this Code section discovers that the deceased is a veteran, 42 the veterans' organization shall notify the funeral director. 43 (e)(1) If the funeral director determines that the deceased is a veteran from information 44 provided by the legally authorized person, any veterans' organization, or otherwise, then 45 such funeral director shall immediately notify the legally authorized person of such 46 finding and shall advise that the deceased person may be eligible to be interred at an 47 appropriate veterans' cemetery. (2) If the funeral director determines that the deceased is a veteran from information 48 49 provided by the legally authorized person, any veterans' organization, or otherwise, and 50 the cremated remains are not claimed by a legally authorized person, then the funeral 51 director shall hold any such cremated remains for at least 60 days. After 60 days, the 52 funeral director shall send written notice to the legally authorized person who signed the 53 cremation authorization form requesting disposition instructions. If the funeral director 54 does not receive a written response from the legally authorized person within 30 days of 55 sending a written notice, then the funeral director shall contact a veterans' organization 56 so that arrangements for the disposition of the cremated remains of the veteran may be 57 made in a state or national veterans' cemetery. 58 (f) Nothing in this Code section shall delay the authorized cremation of a deceased's 59 remains.

- 60 (g)(1) A funeral director complying with this Code section shall be immune from any 61 criminal or civil liability regarding:
