A BILL TO BE ENTITLED AN ACT

- 1 To amend an Act creating the Board of Commissioners of Lincoln County, approved
- 2 February 25, 1949 (Ga. L. 1949, p. 1228), as amended, particularly by an Act approved April
- 3 5, 2002 (Ga. L. 2002, p. 4909), so as to change the description of the commissioner districts;
- 4 to define certain terms and provide for certain inclusions; to provide for continuation in
- 5 office of current members; to provide for the submission of this Act for preclearance under
- 6 Section 5 of the federal Voting Rights Act of 1965, as amended; to provide for related
- 7 matters; to provide effective dates; to repeal conflicting laws; and for other purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 SECTION 1.

- 10 An Act creating the Board of Commissioners of Lincoln County, approved February 25,
- 11 1949 (Ga. L. 1949, p. 1228), as amended, particularly by an Act approved April 5, 2002 (Ga.
- 12 L. 2002, p. 4909), is amended by revising Section 2 as follows:
- 13 "SECTION 2.
- 14 (a) For the purpose of electing members of the board of commissioners, Lincoln County
- is divided into five commissioner districts. Districts 1 through 4 shall be and correspond
- to those four numbered districts described in and attached to and made a part of this Act
- and further identified as 'Plan:lincccsb02-tiger2010edat Plan Type: local Administrator:
- admin User: bak'. District 5 shall consist of Lincoln County in its entirety.
- 19 (b)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall
- 20 mean and describe the same geographical boundaries as provided in the report of the
- Bureau of the Census for the United States decennial census of 2010 for the State of
- Georgia.
- 23 (2) The separate numeric designations in a district description which are underneath a
- VTD heading shall mean and describe individual Blocks within a VTD as provided in the
- 25 report of the Bureau of the Census for the United States decennial census of 2010 for the

26 State of Georgia. Any part of Lincoln County which is not included in any such district 27 described in that attachment shall be included within that district contiguous to such part 28

- which contains the least population according to the United States decennial census of
- 29 2010 for the State of Georgia.
- 30 (3) Any part of Lincoln County which is described in that attachment as being in a
- 31 particular district shall nevertheless not be included within such district if such part is not
- 32 contiguous to such district. Such noncontiguous part shall instead be included within that
- 33 district contiguous to such part which contains the least population according to the
- 34 United States decennial census of 2010 for the State of Georgia.
- 35 (4) Except as otherwise provided in the description of any district, whenever the
- 36 description of such district refers to a named city, it shall mean the geographical
- 37 boundaries of that city as shown on the census map for the United States decennial census
- 38 of 2010 for the State of Georgia."

39 **SECTION 2.**

- 40 The Board of Commissioners of Lincoln County which exists on December 31, 2012, is
- continued in existence but on and after January 1, 2013, shall be constituted as provided in 41
- 42 this Act. The Board of Commissioners of Lincoln County so continued and constituted,
- 43 sometimes referred to in this Act as the 'board,' shall continue to have the powers, duties,
- 44 rights, obligations, and liabilities of that board as existed immediately prior to January 1,
- 45 2013.
- 46 **SECTION 3.**
- 47 The Board of Commissioners of Lincoln County shall through its legal counsel cause this Act
- 48 to be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965,
- 49 as amended, no later than 45 days after the date on which this Act is approved by the
- 50 Governor or otherwise becomes law without such approval.
- 51 **SECTION 4.**
- 52 The provisions of this Act relating to and necessary for the regular election in 2012 of
- members of the Board of Commissioners of Lincoln County shall become effective upon its 53
- approval by the Governor or upon its becoming effective without such approval; and this Act 54
- shall otherwise become effective January 1, 2013. 55
- **SECTION 5.** 56
- All laws and parts of laws in conflict with this Act are repealed. 57
