AS PASSED SENATE

**A BILL TO BE ENTITLED
AN ACT**

1 To amend an Act to provide for the composition and number of state senatorial districts,
2 approved August 24, 2011 (Ga. L. 2011, Ex. Sess., p. 139), so as to revise the boundaries of
3 certain state senate districts; to provide for related matters; to provide an effective date; to
4 provide for delayed applicability under certain circumstances; to repeal conflicting laws; and
5 for other purposes.

6 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

7 **SECTION 1.**

8 An Act to provide for the composition and number of state senatorial districts, approved
9 August 24, 2011 (Ga. L. 2011, Ex. Sess., p. 139), is amended by amending the plan attached
10 thereto and identified as "Plan: Senprop1 Plan Type: Senate Administrator: S028
11 User: Gina" by revising the description of Districts 5, 7, 12, 13, 23, 24, and 48 as follows:

359 **SECTION 2.**

360 This section shall become effective upon the approval of this Act by the Governor or upon
361 this Act becoming law without such approval. The remaining sections of this Act shall
362 become effective upon receipt of preclearance pursuant to Section 5 of the federal Voting
363 Rights Act of 1965, as amended; provided, however, that, if this Act has not received
364 preclearance pursuant to Section 5 of the federal Voting Rights Act of 1965, as amended, by
365 the time of the beginning of qualifying for the 2012 general primary, the remaining sections
366 of this Act shall not be effective for the primary and general elections of 2012 for the purpose
367 of electing members of the Senate who are to take office in 2013, but shall become effective
368 on January 1, 2014, provided this Act has received preclearance as provided by law. If this
369 Act has not received preclearance pursuant to Section 5 of the federal Voting Rights Act of
370 1965, as amended, by December 31, 2013, this Act shall stand automatically repealed by
371 operation of law on January 1, 2014.

372 **SECTION 3.**

373 All laws and parts of laws in conflict with this Act are repealed.
