A BILL TO BE ENTITLED AN ACT

- 1 To amend Article 3 of Chapter 5 of Title 50 of the Official Code of Georgia Annotated,
- 2 relating to state purchasing, so as to change certain provisions relating to purchases without
- 3 competitive bidding, central bid registry, procurement cards, rules and regulations,
- 4 applicability to emergency purchases, and the Purchasing Advisory Council; to change a
- 5 short title; to change certain provisions relating to definitions relative to small business
- 6 assistance; to provide for automatic repeal; to provide effective dates; to repeal conflicting
- 7 laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 Part 1

10 **SECTION 1-1**.

- 11 Article 3 of Chapter 5 of Title 50 of the Official Code of Georgia Annotated, relating to state
- 12 purchasing, is amended by revising subsection (a) of Code Section 50-5-69, relating to
- 13 purchases without competitive bidding, central bid registry, procurement cards, rules and
- 14 regulations, applicability to emergency purchases, and the Purchasing Advisory Council, as
- 15 follows:

- 16 "(a) If the needed supplies, materials, equipment, or service can reasonably be expected
- to be acquired for less than \$5,000.00 \$25,000.00 and is not available on state contracts or
- through statutorily required sources, the purchase may be effectuated without competitive
- bidding. The commissioner of administrative services may by rule and regulation authorize
- 20 the various offices, agencies, departments, boards, bureaus, commissions, institutions,
- 21 authorities, or other entities of the state to make purchases in their own behalf and may
- provide the circumstances and conditions under which such purchases may be effected.
- In order to assist and advise the commissioner of administrative services in making
- determinations to allow offices, agencies, departments, boards, bureaus, commissions,
- institutions, authorities, or other entities of the state to make purchases in their own behalf,
- 26 there is created a Purchasing Advisory Council consisting of the executive director of the

27 Georgia Technology Authority or his or her designee; the director of the Office of Planning and Budget or his or her designee; the chancellor of the University System of Georgia or 28 29 his or her designee; the commissioner of technical and adult education the Technical 30 College System of Georgia or his or her designee; the commissioner of transportation or his or her designee; the Secretary of State or his or her designee; the commissioner of 31 32 human services or his or her designee; the commissioner of community health or his or her 33 designee; the commissioner of public health or his or her designee; the commissioner of 34 behavioral health and developmental disabilities or his or her designee; and one member to be appointed by the Governor. - For the purposes of this part, the term:
- 50 (1) 'Department' means the Department of Administrative Services.
- 51 (2) 'Georgia resident business' means any business that regularly maintains a place from
- 52 which business is physically conducted in Georgia for at least one year prior to any bid
- or proposal to the state or a new business that is domiciled in Georgia and which
- 54 regularly maintains a place from which business is physically conducted in Georgia;
- 55 provided, however, that a place from which business is conducted shall not include a post
- office box, a leased private mailbox, site trailer, or temporary structure.
- 57 (2)(3) 'Small business' means a Georgia resident business which is independently owned
- and operated. In addition, such business must have either fewer than 100 300 employees
- or less than \$1 million \$30 million in gross receipts per year."
