

House Bill 1000 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act creating the Board of Commissioners of Irwin County, approved
2 February 16, 1933 (Ga. L. 1933, p. 571), as amended, particularly by an Act approved
3 February 10, 2004 (Ga. L. 2004, p. 3501), so as to change the description of the
4 commissioner districts; to provide for definitions and inclusions; to provide for the
5 continuation in office of current members; to provide for the submission of this Act pursuant
6 to Section 5 of the federal Voting Rights Act of 1965, as amended; to provide for related
7 matters; to repeal conflicting laws; and for other purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 An Act creating the Board of Commissioners of Irwin County, approved February 16, 1933
11 (Ga. L. 1933, p. 571), as amended, particularly by an Act approved February 10, 2004
12 (Ga. L. 2004, p. 3501), is amended by revising subsections (d) and (e) of Section 1 as
13 follows:

14 "(d) For purposes of electing members of the board other than the chairperson, Irwin
15 County is divided into four commissioner districts, and those districts shall be and
16 correspond to those four districts described in and attached to this Act and made a part
17 hereof and further identified as 'Plan: irwincc-2012 Plan Type: Local Administrator: Irwin
18 Co User: Gina'.

19 (e)(1) For the purposes of such plan:

20 (A) The term 'VTD' shall mean and describe the same geographical boundaries as
21 provided in the report of the Bureau of the Census for the United States decennial
22 census of 2010 for the State of Georgia. The separate numeric designations in a district
23 description which are underneath a VTD heading shall mean and describe individual
24 Blocks within a VTD as provided in the report of the Bureau of the Census for the
25 United States decennial census of 2010 for the State of Georgia; and

26 (B) Except as otherwise provided in the description of any district, whenever the
27 description of any district refers to a named city, it shall mean the geographical
28 boundaries of that city as shown on the census maps for the United States decennial
29 census of 2010 for the State of Georgia.

30 (2) Any part of Irwin County which is not included in any district described in
31 subsection (d) of this section shall be included within that district contiguous to such part
32 which contains the least population according to the United States decennial census of
33 2010 for the State of Georgia.

34 (3) Any part of Irwin County which is described in subsection (d) of this section as being
35 included in a particular district shall nevertheless not be included within such district if
36 such part is not contiguous to such district. Such noncontiguous part shall instead be
37 included within that district contiguous to such part which contains the least population
38 according to the United States decennial census of 2010 for the State of Georgia."

39 **SECTION 2.**

40 (a) Those members of the Board of Commissioners of Irwin County who are serving as such
41 on the effective date of this Act and any person selected to fill a vacancy in any such office
42 shall continue to serve as such members until the regular expiration of their respective terms
43 of office and upon the election and qualification of their respective successors.

44 (b) Commissioner Districts 1, 2, 3, and 4, as they existed immediately prior to the effective
45 date of this Act, shall continue to be designated as Commissioner Districts 1, 2, 3, and 4,
46 respectively, but as newly described under this Act, and, on and after the effective date of
47 this Act, such members of the board serving from those former commissioner districts shall
48 be deemed to be serving from and representing their respective districts as so newly
49 described.

50 **SECTION 3.**

51 The Board of Commissioners of Irwin County shall through its legal counsel cause this Act
52 to be submitted for preclearance under the federal Voting Rights Act of 1965, as amended,
53 not later than 45 days after the date on which this Act is approved by the Governor or
54 otherwise becomes law without such approval.

55 **SECTION 4.**

56 All laws and parts of laws in conflict with this Act are repealed.
