

House Bill 1010 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act to provide for the election of a chairperson and four members of the Worth
2 County Board of Education, approved March 12, 1986 (Ga. L. 1986, p. 3719), as amended,
3 particularly by an Act approved May 13, 2002 (Ga. L. 2002, p. 5740), so as to reapportion
4 the education districts; to define certain terms; to provide for members currently serving; to
5 provide for the submission of this Act to the United States Department of Justice; to provide
6 for related matters; to provide effective dates; to repeal conflicting laws; and for other
7 purposes.

8 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

9 **SECTION 1.**

10 An Act to provide for the election of a chairperson and four members of the Worth County
11 Board of Education, approved March 12, 1986 (Ga. L. 1986, p. 3719), as amended,
12 particularly by an Act approved May 13, 2002 (Ga. L. 2002, p. 5740), is amended by revising
13 subsections (a) and (b) of Section 1 as follows:

14 "(a) The Worth County Board of Education shall consist of a chairperson and four
15 additional members. The chairperson shall be elected by a majority vote of the voters
16 voting from the Worth County School District at large, and the other four members shall
17 be elected from education districts by a majority of voters voting from each district. The
18 chairperson and district members of the board shall serve for terms of four years and until
19 their successors are elected and qualified. For the purpose of electing such members, the
20 Worth County School District shall be divided into four education districts which shall be
21 and correspond to those four numbered districts described in and attached to and made a
22 part of this Act and further identified as 'Plan: worthccsb-2012 Plan Type: Local
23 Administrator: Worth User: bak'.

24 (b) When used in such attachment, the term 'VTD' shall mean and describe the same
25 geographical boundaries as provided in the report of the Bureau of the Census for the
26 United States decennial census of 2010 for the State of Georgia. The separate numeric

27 designations in a district description which are underneath a 'VTD' heading shall mean and
28 describe individual Blocks within a VTD as provided in the report of the Bureau of the
29 Census for the United States decennial census of 2010 for the State of Georgia. Any part
30 of the Worth County School District which is not included in any such district described
31 in that attachment shall be included within that district contiguous to such part which
32 contains the least population according to the United States decennial census of 2010 for
33 the State of Georgia. Any part of the Worth County School District which is described in
34 that attachment as being in a particular district shall nevertheless not be included within
35 such district if such part is not contiguous to such district. Such noncontiguous part shall
36 instead be included within that district contiguous to such part which contains the least
37 population according to the United States decennial census of 2010 for the State of
38 Georgia. Except as otherwise provided in the description of any education district,
39 whenever the description of such district refers to a named city, it shall mean the
40 geographical boundaries of that city as shown on the census map for the United States
41 decennial census of 2010 for the State of Georgia."

42 **SECTION 2.**

43 It is the purpose of this Act to reapportion the districts from which members of the board of
44 education of Worth County are to be elected in the November, 2012, general election and in
45 subsequent general elections, and this Act results from changes in population based on the
46 United States decennial census of 2010. It is not the intention of the General Assembly to
47 affect the membership of current members of the board, their terms of office, or the manner
48 in which their successors shall be elected, and such matters shall remain as provided by law
49 on the effective date of this Act until otherwise amended by law, except to the extent of
50 reapportioning the districts represented by such members.

51 **SECTION 3.**

52 The board of education of Worth County shall through its legal counsel cause this Act to be
53 submitted for preclearance under the federal Voting Rights Act of 1965, as amended; and
54 such submission shall be made to the United States Department of Justice or filed with the
55 appropriate court no later than 45 days after the date on which this Act is approved by the
56 Governor or otherwise becomes law without such approval.

57 **SECTION 4.**

58 The provisions of this Act relating to and necessary for the regular election in 2012 of
59 members of the board of education of Worth County shall become effective upon its approval

60 by the Governor or upon its becoming effective without such approval; and this Act shall
61 otherwise become effective January 1, 2013.

62 **SECTION 5.**

63 All laws and parts of laws in conflict with this Act are repealed.
