

House Bill 1021 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act providing for the composition of the Board of Education for Evans County,
2 approved March 26, 1987 (Ga. L. 1987, p. 4782), as amended, particularly by an Act
3 approved June 3, 2003 (Ga. L. 2003, p. 4281), so as to change the description of the
4 education districts; to provide for definitions and inclusions; to provide for continuation in
5 office of current members; to provide for submission of this Act for preclearance under the
6 federal Voting Rights Act of 1965, as amended; to repeal conflicting laws; and for other
7 purposes.

8 **BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:**

9 **SECTION 1.**

10 An Act providing for the composition of the Board of Education for Evans County, approved
11 March 26, 1987 (Ga. L. 1987, p. 4782), as amended, particularly by an Act approved June
12 3, 2003 (Ga. L. 2003, p. 4281), is amended by revising Section 2 as follows:

13 **"SECTION 2.**

14 (a) For the purpose of electing the six members of the board, other than the chairperson,
15 from education districts, Evans County shall be divided into six education districts. One
16 member of the board shall be elected from each such district. Those districts shall be and
17 correspond to those six numbered districts described in and attached to and made a part of
18 this Act and further identified as 'Plan: evansccsb-2012 Plan Type: Local Administrator:
19 Evans User: bak'.

20 (b)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall
21 mean and describe the same geographical boundaries as provided in the report of the
22 Bureau of the Census for the United States decennial census of 2010 for the State of
23 Georgia.

24 (2) The separate numeric designations in a district description which are underneath a
25 VTD heading shall mean and describe individual Blocks within a VTD as provided in the

26 report of the Bureau of the Census for the United States decennial census of 2010 for the
 27 State of Georgia. Any part of the Evans County School District which is not included in
 28 any such district described in that attachment shall be included within that district
 29 contiguous to such part which contains the least population according to the United States
 30 decennial census of 2010 for the State of Georgia.

31 (3) Any part of the Evans County School District which is described in that attachment
 32 as being in a particular district shall nevertheless not be included within such district if
 33 such part is not contiguous to such district. Such noncontiguous part shall instead be
 34 included within that district contiguous to such part which contains the least population
 35 according to the United States decennial census of 2010 for the State of Georgia.

36 (4) Except as otherwise provided in the description of any district, whenever the
 37 description of such district refers to a named city, it shall mean the geographical
 38 boundaries of that city as shown on the census map for the United States decennial census
 39 of 2010 for the State of Georgia."

40 **SECTION 2.**

41 The Board of Education of Evans County which existed on December 31, 2012, is continued
 42 in existence but on and after January 1, 2013, shall be constituted as provided in this Act.
 43 The Board of Education of Evans County so continued and constituted shall continue to have
 44 the powers, duties, rights, obligations, and liabilities of the board as it existed immediately
 45 prior to January 1, 2013.

46 **SECTION 3.**

47 The Board of Education of Evans County shall through its legal counsel cause this Act to
 48 be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965, as
 49 amended, no later than 45 days after the date on which this Act is approved by the Governor
 50 or otherwise becomes law without such approval.

51 **SECTION 4.**

52 The provisions of this Act relating to and necessary for the regular election in 2012 of
 53 members of the Board of Education of Evans County shall become effective upon its
 54 approval by the Governor or upon its becoming effective without such approval; and this Act
 55 shall otherwise become effective January 1, 2013.

56 **SECTION 5.**

57 All laws and parts of laws in conflict with this Act are repealed.
