

House Bill 1107 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act entitled "An Act to reconstitute the Meriwether County Board of
2 Education," approved March 28, 1985 (Ga. L. 1985, p. 4611), as amended, particularly by
3 an Act approved April 5, 1993 (Ga. L. 1993, p. 4795), so as to change the description of the
4 commissioner districts; to define certain terms and provide for certain inclusions; to provide
5 for continuation in office of current members; to provide for the submission of this Act for
6 preclearance under Section 5 of the federal Voting Rights Act of 1965, as amended; to
7 provide for related matters; to provide effective dates; to repeal conflicting laws; and for
8 other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 style="text-align:center">**SECTION 1.**

11 An Act entitled "An Act to reconstitute the Meriwether County Board of Education,"
12 approved March 28, 1985 (Ga. L. 1985, p. 4611), as amended, particularly by an Act
13 approved April 5, 1993 (Ga. L. 1993, p. 4795), is amended by revising Section 4 as follows:

14 style="text-align:center">"SECTION 4.

15 (a) For the purpose of electing members of the Board of Education of Meriwether County,
16 the Meriwether County School district is divided into five districts. Such districts shall be
17 and correspond to those five numbered districts described in and attached to and made a
18 part of this Act and further identified as 'Plan: meriwetherccsb-2012 Plan Type: local
19 Administrator: Meriwether User: bak'.

20 (b)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall
21 mean and describe the same geographical boundaries as provided in the report of the
22 Bureau of the Census for the United States decennial census of 2010 for the State of
23 Georgia.

24 (2) The separate numeric designations in a district description which are underneath a
25 VTD heading shall mean and describe individual Blocks within a VTD as provided in the

26 report of the Bureau of the Census for the United States decennial census of 2010 for the
27 State of Georgia. Any part of the Meriwether County School District which is not
28 included in any such district described in that attachment shall be included within that
29 district contiguous to such part which contains the least population according to the
30 United States decennial census of 2010 for the State of Georgia.

31 (3) Any part of the Meriwether County School District which is described in that
32 attachment as being in a particular district shall nevertheless not be included within such
33 district if such part is not contiguous to such district. Such noncontiguous part shall
34 instead be included within that district contiguous to such part which contains the least
35 population according to the United States decennial census of 2010 for the State of
36 Georgia.

37 (4) Except as otherwise provided in the description of any district, whenever the
38 description of such district refers to a named city, it shall mean the geographical
39 boundaries of that city as shown on the census map for the United States decennial census
40 of 2010 for the State of Georgia."

41 **SECTION 2.**

42 The Board of Education of Meriwether County which existed on December 31, 2012, is
43 continued in existence but on and after January 1, 2013, shall be constituted as provided in
44 this Act. The Board of Education of Meriwether County so continued and constituted,
45 sometimes referred to in this Act as the "board," shall continue to have the powers, duties,
46 rights, obligations, and liabilities of that board as existed immediately prior to January 1,
47 2013.

48 **SECTION 3.**

49 The Board of Education of Meriwether County shall through its legal counsel cause this Act
50 to be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965,
51 as amended, no later than 45 days after the date on which this Act is approved by the
52 Governor or otherwise becomes law without such approval.

53 **SECTION 4.**

54 The provisions of this Act relating to and necessary for the regular election in 2012 of
55 members of the Board of Education of Meriwether County shall become effective upon its
56 approval by the Governor or upon its becoming effective without such approval; and this Act
57 shall otherwise become effective January 1, 2013.

SECTION 5.

59 All laws and parts of laws in conflict with this Act are repealed.
