

House Bill 1108 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act entitled "An Act to reconstitute the Board of Education of Monroe County,
2 Georgia," approved February 25, 1993 (Ga. L. 1993, p. 3857), as amended, so as to change
3 the description of the districts from which members of such board are elected; to define
4 certain terms; to provide for the submission of this Act for approval pursuant to Section 5 of
5 the federal Voting Rights Act of 1965; to provide effective dates; to repeal conflicting laws;
6 and for other purposes.

7 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

8 **SECTION 1.**

9 An Act entitled "An Act to reconstitute the Board of Education of Monroe County, Georgia,"
10 approved February 25, 1993 (Ga. L. 1993, p. 3857), as amended, is amended by revising
11 subsections (b) and (c) of Section 2 to read as follows:

12 "(b) For purposes of electing a Board of Education of Monroe County, the Monroe County
13 School District shall be divided into seven education districts as provided in this
14 subsection. One member of the board shall be elected from each such district by the voters
15 voting only in such district. The seven education districts shall be and correspond to those
16 seven numbered districts described in and attached to and made a part of this Act and
17 further identified as 'Plan: monroesb-2012 Plan Type: Local Administrator: Monroe SB
18 User: SE'.

19 (c) For the purposes of such plan:

20 (1) The term 'VTD' shall mean and describe the same geographical boundaries as
21 provided in the report of the Bureau of the Census for the United States decennial census
22 of 2010 for the State of Georgia. The separate numeric designations in a district
23 description which are underneath a VTD heading shall mean and describe individual
24 Blocks within a VTD as provided in the report of the Bureau of the Census for the United
25 States decennial census of 2010 for the State of Georgia; and

26 (2) Except as otherwise provided in the description of any district, whenever the
27 description of any district refers to a named city, it shall mean the geographical
28 boundaries of that city as shown on the census maps for the United States decennial
29 census of 2010 for the State of Georgia.

30 (d) Any part of Monroe County which is not included in any district described in
31 subsection (b) of this section shall be included within that district contiguous to such part
32 which contains the least population according to the United States decennial census of 2010
33 for the State of Georgia.

34 (e) Any part of Monroe County which is described in subsection (b) of this section as
35 being included in a particular district shall nevertheless not be included within such district
36 if such part is not contiguous to such district. Such noncontiguous part shall instead be
37 included within that district contiguous to such part which contains the least population
38 according to the United States decennial census of 2010 for the State of Georgia."

39 **SECTION 2.**

40 It is the purpose of this Act to reapportion the districts from which members of the Board of
41 Education of Monroe County are to be elected in the November, 2012, general election and
42 in subsequent general elections, and this Act results from changes in population based on the
43 United States decennial census of 2010. It is not the intention of the General Assembly to
44 affect the membership of current members of the board, their terms of office, or the manner
45 in which their successors shall be elected, and such matters shall remain as provided by law
46 on the effective date of this Act until otherwise amended by law, except to the extent of
47 reapportioning the districts represented by such members.

48 **SECTION 3.**

49 The Board of Education of Monroe County shall cause, through its legal counsel, this Act
50 to be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965,
51 as amended, within 45 days after the date on which this Act is approved by the Governor or
52 otherwise becomes law without such approval.

53 **SECTION 4.**

54 The provisions of this Act relating to and necessary for the regular election in 2012 of
55 members of the Board of Education of Monroe County shall become effective upon its
56 approval by the Governor or upon its becoming law without such approval; and this Act shall
57 otherwise become effective on January 1, 2013.

SECTION 5.

59 All laws and parts of laws in conflict with this Act are repealed.
