- 4 the description of the commissioner districts; to provide for definitions and inclusions; to
- 5 provide for continuation in office of current members; to provide for election and terms of
- 6 office of subsequent members; to provide for related matters; to provide for submission of
- 7 this Act for preclearance under the federal Voting Rights Act of 1965, as amended; to
- 8 provide for related matters; to provide for effective dates; to repeal conflicting laws; and for
- 9 other purposes.

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

- 12 An Act creating the Board of Commissioners of Lamar County, approved March 8, 1943
- 13 (Ga. L. 1943, p. 1066), as amended, particularly by an Act approved July 26, 2001 (Ga. L.
- 14 2001, Ex. Sess., p. 770), is amended by revising Sections 1 through 3A as follows:
- "SECTION 1.
- 16 The Board of Commissioners of Lamar County which existed on December 31, 2012, is
- 17 continued in existence but on and after January 1, 2013, shall be constituted as provided
- in this Act. The Board of Commissioners of Lamar County so continued and constituted,
- sometimes referred to in this Act as the 'board,' shall continue to have the powers, duties,
- rights, obligations, and liabilities of that board as existed immediately prior to January 1,
- 21 2013.
- SECTION 2.
- 23 (a) Those members of the Board of Commissioners of Lamar County who are serving as
- such on December 31, 2012, and any person selected to fill a vacancy in any such office

shall continue to serve as such members until the regular expiration of their respective terms of office and until the election and qualification of their respective successors. On and after January 1, 2013, the Board of Commissioners of Lamar County shall consist of five members all of whom shall be elected from commissioner districts described in subsection (b) of this section except for the member who is chairperson and who is elected at large as provided in Section 3.

- 31 (b) For purposes of electing members of the board of commissioners, other than the 32 chairperson, Lamar County is divided into four commissioner districts. One member of 33 the board shall be elected from each such district. The four commissioner districts shall 34 be and correspond to those four numbered districts described in and attached to and made
- a part of this Act and further identified as 'Plan: lamarccsb-2012 Plan Type: Local
- 36 Administrator: Lamar User: Gina'.

- 37 (c)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall 38 mean and describe the same geographical boundaries as provided in the report of the 39 Bureau of the Census for the United States decennial census of 2010 for the State of 40 Georgia.
- 41 (2) The separate numeric designations in a district description which are underneath a
  42 VTD heading shall mean and describe individual Blocks within a VTD as provided in the
  43 report of the Bureau of the Census for the United States decennial census of 2010 for the
  44 State of Georgia. Any part of Lamar County which is not included in any such district
  45 described in that attachment shall be included within that district contiguous to such part
  46 which contains the least population according to the United States decennial census of
  - (3) Any part of Lamar County which is described in that attachment as being in a particular district shall nevertheless not be included within such district if such part is not contiguous to such district. Such noncontiguous part shall instead be included within that district contiguous to such part which contains the least population according to the United States decennial census of 2010 for the State of Georgia.
- 53 (4) Except as otherwise provided in the description of any commissioner district, 54 whenever the description of such district refers to a named city, it shall mean the 55 geographical boundaries of that city as shown on the census map for the United States 56 decennial census of 2010 for the State of Georgia.

57 SECTION 3.

(a) No person shall be a member of the board if that person is ineligible for such office pursuant to Code Section 45-2-1 of the O.C.G.A. or any other general law applicable to that office.

(b) In order to be elected as a member of the board from a commissioner district, a person must receive the number of votes cast as required by general law for that office in that district only. Only electors who are residents of that commissioner district may vote for a member of the board for that district. At the time of qualifying for election as a member of the board from a commissioner district, each candidate for such office shall specify the commissioner district for which that person is a candidate. A person elected or appointed as a member of the board from a commissioner district must continue to reside in that district during that person's term of office or that office shall become vacant.

- (c) The member of the board who is chairperson of the board may reside anywhere within Lamar County and, if elected, must receive the number of votes cast for that office as required by general law in the entire county. The chairperson must continue to reside within the county during that person's term of office or that office shall become vacant.
- 73 (d) Before entering upon the discharge of such commissioner's duties, each commissioner 74 shall take and subscribe to the following oath, to wit: 'I do solemnly swear that I will support the Constitution of the United States and of the State of Georgia, and that I will 75 76 well, truly, and faithfully discharge the duties of commissioner of Lamar County, during 77 my continuance in office according to law and to the best of my knowledge and ability, 78 without fear or affection of any person, firm, or corporation; so help me God.' Each of said 79 commissioners shall give a bond in the sum of \$1,000.00 each, except the chairperson of 80 said board, who shall give a bond in the sum of \$10,000.00, in a good and solvent fidelity 81 and guaranty company, payable to the judge of the probate court of said county and his or 82 her successors in office, conditioned upon the faithful discharge of the duties of his or her 83 office, which shall be duly filed and recorded in the office of the judge of the probate court of said county, as the bond of other county officers. The premium on said bonds shall be 84 85 paid as provided by Code Section 45-4-7 of the O.C.G.A. Said commissioners shall each 86 be commissioned by the Governor, and all future commissioners shall be commissioned likewise. 87
- (e) The board shall elect one of its members as vice chairperson who, in the absence or disqualification of the chairperson or during a vacancy in the office of chairperson, shall perform and discharge all of the duties and functions of the chairperson.
- 91 (f) A quorum for the conduct of business shall be three members. The chairperson shall be a member for purposes of achieving a quorum.

93 SECTION 3A.

(a) The first members of the reconstituted Board of Commissioners of Lamar County shall be elected at the general election on the Tuesday next following the first Monday in November, 2012. Those members of the board elected thereto from Commissioner

Districts 3 and 4 in 2012 shall take office the first day of January immediately following that election and shall serve for initial terms of office which expire December 31, 2016, and until the election and qualification of their respective successors. The chairperson and those members of the board elected thereto from Commissioner Districts 1 and 2 in 2014 shall take office the first day of January immediately following that election and shall serve for initial terms of office which expire December 31, 2018, and until the election and qualification of their respective successors. Those and all future successors to members of the board whose terms of office are to expire shall be elected at the time of the state-wide general election immediately preceding the expiration of such terms, shall take office the first day of January immediately following that election, and shall serve for terms of office of four years each. Members of the board shall serve for the terms of office specified therefor in this subsection and until their respective successors are elected and qualified.

110 (b) All members of the board who are elected thereto shall be nominated and elected in 111 accordance with Chapter 2 of Title 21 of the O.C.G.A., the 'Georgia Election Code.'

(c) Commissioner Districts 1 through 4, as they exist on December 31, 2012, shall continue to be designated as Commissioner Districts 1 through 4, respectively, but as newly described under this Act, and on and after January 1, 2013, such members of the board serving from those former commissioner districts shall be deemed to be serving from and representing their respective districts as newly described under this section."

117 SECTION 2.

The Board of Commissioners of Lamar County shall through its legal counsel cause this Act to be submitted for preclearance under the federal Voting Rights Act of 1965, as amended; and such submission shall be made to the United States Department of Justice or filed with the appropriate court no later than 45 days after the date on which this Act is approved by the Governor or otherwise becomes law without such approval.

**SECTION 3.** 

This section and Section 2 of this Act and those provisions of this Act necessary for the election of members of the Board of Commissioners of Lamar County in 2012 shall become effective upon the approval of this Act by the Governor or upon its becoming law without such approval. The remaining provisions of this Act shall become effective January 1, 2013.

129 All laws and parts of laws in conflict with this Act are repealed.
