A RESOLUTION

- 1 Honoring the life and memory of Ms. Louversia L. Wiggins; and for other purposes.
- 2 WHEREAS, the State of Georgia mourns the loss of one of its most distinguished citizens
3 with the passing of Ms. Louversia L. Wiggins; and
- 4 WHEREAS, Ms. Wiggins was a natural leader, a caring neighbor, and local activist whose
5 efforts and work touched the lives of many Georgians; and
- 6 WHEREAS, she earned a bachelor's degree from Atlanta Metropolitan College and served
7 as a bookkeeper, administrative assistant, and office manager for Saint Anthony's Catholic
8 School in Atlanta, Christian Emergency Help Centers in Atlanta, and Forest Hills Financial
9 Group in New York; and
- 10 WHEREAS, Ms. Wiggins diligently and conscientiously devoted innumerable hours of her
11 time, talents, and energy toward the betterment of her community and state as evidenced
12 dramatically by her superlative service as an analyst and accountant with the City of Atlanta;

- 14 WHEREAS, a community leader, Ms. Wiggins served on her Neighborhood Planning Unit,
15 the West Atlanta Watershed Alliance, the Atlanta Housing Authority-Housing Choice
16 Community Advisory Group, the Atlanta Planning Advisory Board, the Fulton County
17 Combined Sewer Overflow Committee, and the Charlie Brown/Fulton County Airport
18 Master Plan Steering Committee; and
- 19 WHEREAS, she gave inspiration to many through her high ideals, morals, and deep concern
20 for her fellow citizens, and the devotion, patience, and understanding she demonstrated to
21 her family and friends were admired by others; and

22 WHEREAS, she was a person of magnanimous strengths with an unimpeachable reputation
23 for integrity, intelligence, fairness, and kindness and, by the example she made of her life,
24 she made this world a better place in which to live; and

25 WHEREAS, a compassionate and generous woman, Ms. Wiggins will long be remembered
26 for her love of family and friendship, and this loyal leader and friend will be missed by all
27 who had the great fortune of knowing her.

28 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
29 join in honoring the life and memory of Ms. Louversia L. Wiggins and express their deepest
30 and most sincere regret at her passing.
