A RESOLUTION

- 1 Recognizing and commending Mr. Andre Kenneth "Chase" Randall; and for other purposes.
- 2 WHEREAS, long-time Atlanta resident Mr. Andre Kenneth "Chase" Randall took courses
3 from the University of Missouri in Columbia and Kansas City, Georgia State University, and
4 Morehouse College and received a certificate in paralegal/legal assistant studies from Black
5 Career Institute in 2008; and
- 6 WHEREAS, along with some college friends, Mr. Randall created a group called "Positive
7 Education Always Creates Elevation" (P.E.A.C.E.) in 1995 and they joined together in
8 mentoring community youths, as well as providing after school tutoring, French classes, a
9 summer academy, a community garden, planning sessions for a community development
10 credit union, and programs for senior citizens; and
- 11 WHEREAS, P.E.A.C.E. became a Corporation for National and Community Service
12 AmeriCorps Volunteers in Service to America (V.I.S.T.A.) site within six months; and
- 13 WHEREAS, in 1997, Mr. Randall transitioned to the Community Empowerment Advisory
14 Board (C.E.A.B.) as a representative who served as assistant treasurer assisting with the
15 agency's \$1.2 million budget; and
- 16 WHEREAS, he worked with the Historic District Development Corporation (HDDC) in its
17 mission to facilitate the preservation and revitalization of the Martin Luther King, Jr.,
18 National Historic District and other historic/preservation communities; and
- 19 WHEREAS, he volunteers his time to various nonprofit organizations, including the Sullivan
20 Center and the Villages of Carver YMCA; and

21 WHEREAS, he currently serves as the chair of the Neighborhood Planning Unit X Economic
22 Development Committee and is a member and owner of Sevananda, a community owned
23 natural foods market; and

24 WHEREAS, a man of deep and abiding faith, Mr. Randall is an active member of Tabernacle
25 Baptist Church in the Old Fourth Ward community; and

26 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
27 distinguished Georgian be appropriately recognized.

28 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
29 the members of this body commend Mr. Andre Kenneth "Chase" Randall for his effective,
30 efficient, unselfish, and dedicated public service to his community and state and extend to
31 him their sincere best wishes for continued health and happiness.
