- 1 Celebrating the life of Hugh Carroll Butler and dedicating a bridge in his memory; repealing
- 2 a certain resolution; repealing conflicting laws; and for other purposes.

- 5 WHEREAS, he lived in Port Wentworth, Georgia, for 48 years after moving to the area with

- 7 WHEREAS, he was a member of the city council of Port Wentworth for 20 years; and
- 8 WHEREAS, he served for many years as the chairman of the Good Samaritan Committee
- 9 of Port Wentworth, which was formed to help travelers in need of assistance and to deliver
- 10 baskets of food to needy families during the Christmas season; and
- 11 WHEREAS, Carroll was a member of the Lions Club for over 25 years and served as its
- 12 president on several occasions; and
- 13 WHEREAS, he was an active member of the First Baptist Church of Port Wentworth for 45
- 14 years, serving as a deacon and Sunday school director; and
- 15 WHEREAS, he and his wife of nearly 55 years, Carolyn Scott Butler, were blessed with two
- 16 children, four grandchildren, and two great-grandchildren; and
- 17 WHEREAS, it is only fitting and proper that the life well lived of Hugh Carroll Butler, with
- 18 his devotion to his family, his church, his community, and his country, be memorialized with
- 19 a lasting monument.

20 NOW, THEREFORE, BE IT RESOLVED AND ENACTED BY THE GENERAL

- 21 ASSEMBLY OF GEORGIA:
- 22 (1) That the bridge on SR 25 over the Norfolk Southern railroad tracks in the city limits
- of Port Wentworth in Chatham County is dedicated as the Hugh Carroll Butler Memorial
- 24 Bridge;
- 25 (2) That the Department of Transportation is authorized and directed to erect and
- 26 maintain appropriate signs dedicating the Hugh Carroll Butler Memorial Bridge;
- 27 (3) That Part V and the fifth undesignated paragraph of Part XXVIII of House
- Resolution 507 (Ga. L. 2011, p. 900) are hereby repealed;
- 29 (4) That the Clerk of the House of Representatives is authorized and directed to transmit
- appropriate copies of this resolution to the family of Mr. Hugh Carroll Butler and to the
- 31 Department of Transportation; and
- 32 (5) That all laws and parts of laws in conflict with this Resolution are repealed.
