A RESOLUTION

- 1 Recognizing and commending Ms. Cynthia Williams; and for other purposes.
- 2 WHEREAS, Ms. Cynthia Williams has long been recognized by the citizens of this state for
3 the vital role that she has played in leadership and her deep personal commitment to the
4 welfare of the citizens of Georgia; and
- 5 WHEREAS, Ms. Williams is the immediate past president of the National Coalition of 100
6 Black Women, Inc., (NCBW) Metropolitan Atlanta Chapter; and
- 7 WHEREAS, she is a consummate community leader and extremely passionate about
8 collaborating with others who have shared objectives to enhance the livelihood of African
9 American women and children in the areas of health, education, and economic development;

- 11 WHEREAS, she was co-chair of the NCBW Biennial Conference in 2009 and International
12 Advocacy Committee; and
- 13 WHEREAS, she implemented a donation drive amongst 62 chapters of the NCBW consisting
14 of cash, clothing, books, toiletries, and other items to provide assistance to Liberia,
15 surpassing the fundraising goal; and
- 16 WHEREAS, she played an instrumental role in getting Delta Air Lines to add a direct flight
17 from Atlanta to Monrovia, Liberia, and in hosting a health event in conjunction with National
18 HIV/AIDS Testing Day; and
- 19 WHEREAS, Ms. Williams has received numerous honors, including the Chapter of the Year
20 Award in 2009; and

21 WHEREAS, she has diligently and conscientiously devoted innumerable hours of her time,
22 talents, and energy toward the betterment of her community and state as evidenced
23 dramatically by her superlative service as president of the NCBW; and

24 WHEREAS, her significant organizational and leadership talents, her remarkable patience
25 and diplomacy, her keen sense of vision, and her sensitivity to the needs of the citizens of
26 this state have earned her the respect and admiration of her colleagues and associates; and

27 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
28 remarkable and distinguished Georgian be appropriately recognized.

29 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
30 the members of this body commend Ms. Cynthia Williams for her efficient, effective,
