The Senate State and Local Governmental Operations Committee offered the following substitute to HB 1196:

# A BILL TO BE ENTITLED AN ACT

To amend an Act known as the "Macon Water Authority Act," approved March 23, 1992 (Ga. L. 1992, p. 4991), as amended, particularly by an Act approved May 1, 2002 (Ga. L. 2002, p. 5363), so as to change the description of the electoral districts; to provide for definitions and inclusions; to provide for the continuation in office of current members; to provide for the submission of this Act for preclearance pursuant to Section 5 of the federal Voting Rights Act of 1965, as amended; to provide for related matters; to repeal conflicting laws; and for other purposes.

#### BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

#### **SECTION 1.**

An Act known as the "Macon Water Authority Act," approved March 23, 1992 (Ga. L. 1992,
p. 4991), as amended, particularly by an Act approved May 1, 2002 (Ga. L. 2002, p. 5363),
is amended by revising paragraphs (2) and (3) of subsection (b) of Section 2 as follows:

13 "(2) For the purpose of electing members of the authority, Bibb County and parts of

14 Jones County are divided into five electoral districts as follows:

- (A) Districts 1 through 4 shall be and correspond to those numbered districts described
  in and attached to and made a part of this Act and further identified as
  'Plan: MWA-2012-s018 Plan Type: Local Administrator: s018 User: Gina'; and
  (B) District 5 shall consist of all of Bibb County and all those parts of Jones County
  included in District 1.
- 20 (3)(A) For the purposes of such plan:

(i) The term 'VTD' shall mean and describe the same geographical boundaries as
provided in the report of the Bureau of the Census for the United States decennial
census of 2010 for the State of Georgia. The separate numeric designations in a
district description which are underneath a VTD heading shall mean and describe
individual Blocks within a VTD as provided in the report of the Bureau of the Census
for the United States decennial census of 2010 for the State of Georgia; and

- (ii) Except as otherwise provided in the description of any district, whenever the description of any district refers to a named city, it shall mean the geographical boundaries of that city as shown on the census maps for the United States decennial census of 2010 for the State of Georgia.
- (B) Any part of Bibb County which is not included in any district described in
  subparagraph (A) of paragraph (2) of this subsection shall be included within that
  district contiguous to such part which contains the least population according to the
  United States decennial census of 2010 for the State of Georgia.
- 35 (C) Any part of Bibb County and those parts of Jones County which are described in 36 subparagraph (A) of paragraph (2) of this subsection as being included in a particular 37 district shall nevertheless not be included within such district if such part is not 38 contiguous to such district. Such noncontiguous part shall instead be included within 39 that district contiguous to such part which contains the least population according to 40 the United States decennial census of 2010 for the State of Georgia."

#### **SECTION 2.**

(a) Those elected members of the Macon Water Authority who are serving as such on the
effective date of this Act and any person selected to fill a vacancy in any such office shall
continue to serve as such members until the regular expiration of their respective terms of
office and upon the election and qualification of their respective successors.

(b) Districts 1, 2, 3, 4, and 5, as they exist immediately prior to the effective date of this Act,
shall continue to be designated as Districts 1, 2, 3, 4, and 5, respectively, but as newly
described under this Act, and on and after the effective date of this Act, such members of the
board serving from those former districts shall be deemed to be serving from and
representing their respective districts as newly described under this Act.

## **SECTION 3.**

52 The Macon Water Authority shall through its legal counsel cause this Act to be submitted 53 for preclearance under Section 5 of the federal Voting Rights Act of 1965, as amended, not 54 later than 45 days after the date on which this Act is approved by the Governor or otherwise 55 becomes law without such approval.
