- 1 Recognizing and commending Piedmont Newnan Hospital and Piedmont Healthcare; and for
- 2 other purposes.
- 3 WHEREAS, Piedmont Newnan Hospital is a 136 bed, nonprofit acute care hospital located
- 4 in Coweta County; and
- 5 WHEREAS, Piedmont Newnan Hospital provides emergency, inpatient, medical and
- 6 surgical, outpatient, imaging and diagnostics, and women's services and maintains an
- 7 ambulatory surgery center; and
- 8 WHEREAS, Piedmont Newnan Hospital has more than 800 employees and an annual
- 9 economic benefit of more than \$157 million to the local community and to Georgia citizens;

- 11 WHEREAS, each Coweta hospital job supports approximately 1.4 additional jobs in the
- overall economy and every dollar spent by a hospital supports almost \$1.54 in additional
- 13 business activity; and
- 14 WHEREAS, Piedmont Healthcare acquired Piedmont Newnan Hospital in 2007 and
- 15 committed to the community to build a replacement facility of the existing 14-year-old
- 16 hospital so that it would provide the latest state-of-the-art medical technology with
- 17 convenient community access; and
- 18 WHEREAS, Piedmont Hospital invested more than \$162 million in constructing the new
- 19 hospital that will open May 8, 2012; and
- 20 WHEREAS, Piedmont Newnan Hospital will be one of the first LEED certified hospitals in
- 21 Georgia, which is an internationally recognized green building certification that combines

- 24 WHEREAS, the new hospital is made up of 362,376 square feet on 105 acres and is designed
- 25 for improved patient access and way finding, flexibility, and operational efficiencies; and
- 26 WHEREAS, under the leadership of Piedmont Newnan Hospital President and CEO Michael
- 27 Bass and Piedmont Healthcare President and CEO R. Timothy Stack, this five-year project
- 28 became a reality even in the face of one of the worst economic recessions in the country; and
- 29 WHEREAS, Mr. Bass and the employees, physicians, and volunteers have worked tirelessly
- 30 to build a world class health facility in Coweta focused on providing access to state-of-the-art
- 31 medical equipment and services.

- 33 the members of this body commend the leadership of Piedmont Newnan Hospital and
