A BILL TO BE ENTITLED AN ACT

- 1 To amend Part 4 of Article 2 of Chapter 2 of Title 21 of the Official Code of Georgia
- 2 Annotated, relating to poll officers, so as to provide for the Student Teen Election Participant
- 3 program; to provide for related matters; to provide an effective date; to repeal conflicting
- 4 laws; and for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA: 5

6 **SECTION 1.** 7 Part 4 of Article 2 of Chapter 2 of Title 21 of the Official Code of Georgia Annotated,

- 8 relating to poll officers, is amended by revising Code Section 21-2-92, relating to
- 9 qualification of poll officers and service during municipal election or primary, by adding a
- 10 new subsection to read as follows:
- 11 "(c) Each local board of education and election superintendent shall be authorized to
- 12 develop and implement through a coordinated effort a Student Teen Election Participant
- 13 (STEP) program. The STEP program shall permit full-time public, private, and home
- 14 schooled high school students to volunteer to work as poll officers during any primary,
- 15 special, or general election. In addition to the qualifications set forth in subsection (a) of
- 16 this Code section, a student participating in the STEP program shall:
- 17 (1) Be a United States citizen;
- (2) Have a Georgia driver's license or Georgia state-issued identification card; 18
- 19 (3) Have demonstrated age-appropriate academic ability for the previous school year;
- 20 and
- 21 (4) Have a history of responsible school and community behavior.
- 22 A student participating in the STEP program shall at all times while working as a poll
- 23 officer remain under the supervision of an adult poll officer or manager who is 21 years of
- 24 age or older. No student shall be permitted to participate in the STEP program without the
- 25 written authorization of his or her parent or legal guardian and such other documentation
- 26 as may be required by the local board of education or election superintendent. A student

27 in the STEP program shall work a minimum of four but not more than six hours during a single election day and shall receive age-appropriate training for serving as a poll officer. 28 29 A student who successfully participates in the STEP program shall be counted as present and given full credit for the school day during which he or she served in the STEP 30 31 program. No student shall be permitted to be absent from school or participate in the STEP program for more than two school days. The election superintendent and local board of 32 33 education shall adopt mutually agreed upon rules, regulations, and policies prior to the initiation of a STEP program." 34

35 **SECTION 2.**

- 36 This Act shall become effective upon its approval by the Governor or upon its becoming law
- 37 without such approval.

38 SECTION 3.

39 All laws and parts of laws in conflict with this Act are repealed.
