

House Bill 1239 (AS PASSED HOUSE AND SENATE)

A BILL TO BE ENTITLED  
AN ACT

1 To amend an Act providing for the election of members of the board of education of Tattnall  
2 County, approved February 29, 1968 (Ga. L. 1968, p. 2077), as amended, particularly by an  
3 Act approved April 11, 2002 (Ga. L. 2002, p. 3922), and by an Act approved May 30, 2003  
4 (Ga. L. 2003, p. 3802), so as to change the description of the education districts; to define  
5 certain terms and provide for certain inclusions; to provide for continuation in office of  
6 current members; to provide for the submission of this Act for preclearance under Section  
7 5 of the federal Voting Rights Act of 1965, as amended; to provide for related matters; to  
8 provide effective dates; to repeal conflicting laws; and for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 **SECTION 1.**

11 An Act providing for the election of members of the board of education of Tattnall County,  
12 approved February 29, 1968 (Ga. L. 1968, p. 2077), as amended, particularly by an Act  
13 approved April 11, 2002 (Ga. L. 2002, p. 3922), and by an Act approved May 30, 2003 (Ga.  
14 L. 2003, p. 3802), is amended by revising Section 2 as follows:

15 "SECTION 2.

16 (a) For the purpose of electing members of Tattnall County Board of Education, the Tattnall  
17 County School District is divided into five districts. Such districts shall be and correspond  
18 to those five numbered districts described in and attached to and made a part of this Act and  
19 further identified as 'Plan: tattnallccsb-2012 Plan Type: Local Administrator: Tattnall User:  
20 Gina'.

21 (b)(1) When used in such attachment, the term 'VTD' (voting tabulation district) shall  
22 mean and describe the same geographical boundaries as provided in the report of the  
23 Bureau of the Census for the United States decennial census of 2010 for the State of  
24 Georgia.

25 (2) The separate numeric designations in a district description which are underneath a  
 26 VTD heading shall mean and describe individual Blocks within a VTD as provided in the  
 27 report of the Bureau of the Census for the United States decennial census of 2010 for the  
 28 State of Georgia. Any part of the Tattnall County School District which is not included  
 29 in any such district described in that attachment shall be included within that district  
 30 contiguous to such part which contains the least population according to the United States  
 31 decennial census of 2010 for the State of Georgia.

32 (3) Any part of the Tattnall County School District which is described in that attachment  
 33 as being in a particular district shall nevertheless not be included within such district if  
 34 such part is not contiguous to such district. Such noncontiguous part shall instead be  
 35 included within that district contiguous to such part which contains the least population  
 36 according to the United States decennial census of 2010 for the State of Georgia.

37 (4) Except as otherwise provided in the description of any district, whenever the  
 38 description of such district refers to a named city, it shall mean the geographical  
 39 boundaries of that city as shown on the census map for the United States decennial census  
 40 of 2010 for the State of Georgia."

41 **SECTION 2.**

42 The Board of Education of Tattnall County which existed on December 31, 2012, is  
 43 continued in existence but on and after January 1, 2013, shall be constituted as provided in  
 44 this Act. The Board of Education of Tattnall County so continued and constituted,  
 45 sometimes referred to in this Act as the 'board,' shall continue to have the powers, duties,  
 46 rights, obligations, and liabilities of that board as existed immediately prior to January 1,  
 47 2013.

48 **SECTION 3.**

49 The Board of Education of Tattnall County shall through its legal counsel cause this Act to  
 50 be submitted for preclearance under Section 5 of the federal Voting Rights Act of 1965, as  
 51 amended, no later than 45 days after the date on which this Act is approved by the Governor  
 52 or otherwise becomes law without such approval.

53 **SECTION 4.**

54 The provisions of this Act relating to and necessary for the regular election in 2012 of  
 55 members of the Board of Education of Tattnall County shall become effective upon its  
 56 approval by the Governor or upon its becoming effective without such approval; and this Act  
 57 shall otherwise become effective January 1, 2013.

**SECTION 5.**

59 All laws and parts of laws in conflict with this Act are repealed.
