1 Recognizing and commending Ms. Tracye D. Bryant; and for other purposes.

2 WHEREAS, Ms. Tracye D. Bryant has long been recognized by the citizens of this state for
3 the vital role that she has played in leadership and her deep personal commitment to the
4 welfare of the citizens of Georgia; and

5 WHEREAS, Ms. Bryant earned a bachelor's degree in communications from Mercer
6 University, a master's degree in public administration from Strayer University, and is
7 currently working on a doctorate degree in public policy and administration; and

8 WHEREAS, she was the public relations director at Southern Regional Hospital in Riverdale
9 and currently is chief executive officer of Azyre Entertainment, Inc., a public relations firm
10 established in January of 2003 that manages various types of public relations needs for
11 celebrities, nonprofit organizations, athletes, and politicians; and

12 WHEREAS, she played a key role in organizing community health fairs, was a volunteer
13 coordinator for the American Cancer Society's annual Relay for Life event, and participated
14 in the Clayton Village Anti-Violence Task Force; and

16 of Directors, Atlanta Association of Black Journalists Advisory Board, the DeShawn Snow
17 Foundation, and previously served on the American Red Cross Minority Recruitment

19 WHEREAS, she has received numerous honors, including the Trumpet Awards Foundation's
20 2012 High Heels Award and the 2012 Volunteer of the Year from the Atlanta Association
21 of Black Journalists; and

22 WHEREAS, she is the proud mother of two remarkable sons, Avery and Mason, and an
23 active member of Elizabeth Baptist Church; and

24 WHEREAS, Ms. Bryant's significant organizational and leadership talents, her remarkable
25 patience and diplomacy, her keen sense of vision, and her sensitivity to the needs of the
26 citizens of this state have earned her the respect and admiration of her colleagues and
27 associates; and

28 WHEREAS, it is abundantly fitting and proper that the outstanding accomplishments of this
29 remarkable and distinguished Georgian be appropriately recognized.

30 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES that
