A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 2 of Chapter 2 of Title 40 of the Official Code of Georgia Annotated,  
2 relating to registration and licensing of motor vehicles generally, so as to provide that  
3 temporary plates or "drive-out tags" may be issued for trailers; to provide that temporary  
4 transporter plates issued to motor vehicles may also be issued for the temporary transport of  
5 trailers; to amend Article 3 of Chapter 2 of Title 40 of the Official Code of Georgia  
6 Annotated, relating to prestige license plates and special plates for certain persons and  
7 vehicles, so as to allow for veterans deemed partially disabled to qualify for a free license  
8 plate and annual revalidation decal; to include persons still serving in the armed services; to  
9 provide for images to disabled veterans license plates; to add veterans who served in certain  
10 wars; to provide for special license plates for veterans and service members awarded certain  
11 distinguished service medals; to provide for license plates to promote prostate cancer  
12 awareness; to provide for a special license plate to promote lung cancer awareness, research,  
13 and treatment of lung cancer; to provide for a special license plate for supporting nurses in  
14 Georgia and the nursing profession; to provide for procedures; to provide that persons issued  
15 special license plates as certified firefighters shall be exempt from paying an annual special  
16 license plate renewal fee; to provide for related matters; to repeal conflicting laws; and for  
17 other purposes.

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

19 style="text-align:center">**SECTION 1.**

20 Article 2 of Chapter 2 of Title 40 of the Official Code of Georgia Annotated, relating to  
21 registration and licensing of motor vehicles generally, is amended by revising Code Section  
22 40-2-38.1, relating to transporter license plate, as follows:

23 "40-2-38.1.

24 (a) A person engaged in the business of the limited operation of a motor vehicle or trailer  
25 for any of the following purposes may obtain a transporter plate authorizing the movement  
26 of the vehicle for the specific purpose:

- 27 (1) To facilitate the delivery of new or used motor vehicles, trucks, trailers, or buses  
28 between manufacturers, distributors, dealers, sellers, or purchasers;
- 29 (2) To move a mobile office, a mobile classroom, a mobile or manufactured home, or a  
30 house trailer;
- 31 (3) To drive a motor vehicle or pull a trailer that is part of the inventory of a dealer to  
32 and from a motor vehicle or trailer trade show or exhibition or to, during, and from a  
33 parade in which the motor vehicle or trailer is used; or
- 34 (4) To drive special mobile equipment in any of the following circumstances:
- 35 (A) From the manufacturer of the equipment to a facility of a dealer; or  
36 (B) From one facility of a dealer to another facility of a dealer.
- 37 (b) This Code section shall not be construed to require a motor vehicle or trailer dealer to  
38 obtain transporter plates in order to transport vehicles for sale or lease.
- 39 (c) A person may obtain a transporter plate by filing an application with the Department  
40 of Revenue and paying the required fee. The fee for an initial transporter plate shall be  
41 \$62.00 and the fee for all additional plates shall be \$12.00. An application for a transporter  
42 plate must be on a form provided by the department and must contain the information  
43 required by the department. The department is authorized to promulgate regulations  
44 consistent with this Code section.
- 45 (d) Transporter plates issued under this Code section shall be distinguishable from dealer,  
46 wholesaler, manufacturer, or distributor plates, as provided for in Code Section 40-2-38.
- 47 (e) During the year for which it is issued, a person may transfer a transporter plate from  
48 one vehicle to another so long as the vehicle is driven or pulled only for a purpose  
49 authorized by subsection (a) of this Code section. In order to obtain a transporter plate, an  
50 applicant must demonstrate to the department compliance with all applicable federal and  
51 state laws.
- 52 (f) The license plates issued pursuant to this Code section shall be revoked and confiscated  
53 upon a determination after a hearing that an applicant has unlawfully used such license  
54 plates for purposes other than those expressly permitted by this Code section.
- 55 (g) If a license plate issued pursuant to this Code section is lost or stolen, the dealer,  
56 manufacturer, distributor, or other party to whom the license plate was issued must  
57 immediately report the lost or stolen plate to local law enforcement agencies. If a  
58 replacement license plate is sought, the dealer, manufacturer, distributor, or other party to  
59 whom the license plate was issued shall file a notarized affidavit with the department  
60 requesting a replacement plate. Such affidavit shall certify under penalty of perjury that  
61 the license plate has been lost or stolen and that the loss has been reported to a local law  
62 enforcement agency.
- 63 (h) This Code section shall not in any way apply to farm tractors.

64 (i)(1) The expiration of a license plate issued pursuant to this Code section shall be the  
 65 last day of the registration period as provided in division (a)(1)(A)(ii) of Code Section  
 66 40-2-21, except that for the purposes of this subsection, the registration period shall be  
 67 determined by the first letter of the legal name of the business listed on the application  
 68 for registration or renewal of registration. An application for renewal of registration shall  
 69 not be submitted earlier than 90 days prior to the last day of the registration period. A  
 70 penalty of 25 percent of the total registration fees due shall be assessed any person  
 71 registering pursuant to this Code section who, prior to the expiration of such person's  
 72 registration period, fails to apply for renewal or if having applied fails to pay the required  
 73 fees.

74 (2) A transition period shall commence on October 1, 2007, and conclude on December  
 75 31, 2007, for all existing registrations and any new registration applications presented  
 76 prior to January 1, 2008. On or after January 1, 2008, new applications for registration  
 77 shall be submitted and remain valid until the expiration of such registration as specified  
 78 in paragraph (1) of this subsection.

79 (j) The commissioner shall adopt rules and regulations for the implementation of this Code  
 80 section."

## SECTION 2.

82 Article 3 of Chapter 2 of Title 40 of the Official Code of Georgia Annotated, relating to  
 83 prestige license plates and special plates for certain persons and vehicles, is amended by  
 84 revising Code Section 40-2-70, relating to free license plates and revalidation decals for  
 85 disabled veterans, as follows:

86 "40-2-70.

87 (a) Any citizen and resident of the State of Georgia who has been discharged from the  
 88 armed forces under conditions other than dishonorable or who is currently serving in the  
 89 armed forces, who is disabled to any degree specified and enumerated in Code Section  
 90 40-2-69, and who is the owner of a private passenger motor vehicle, but who cannot qualify  
 91 under Code Section 40-2-69, shall be entitled to a special and distinctive automobile  
 92 license plate. Such license plate shall be transferred to another vehicle acquired by such  
 93 veteran or jointly by such veteran and his or her spouse as provided in Code Section  
 94 40-2-80. Such veteran shall be entitled to such plate regardless of whether he or she is  
 95 suffering from a service connected or nonservice connected disability.

96 (b) Such veteran must apply for such license plate and, upon compliance with the state  
 97 motor vehicle laws for licensing of motor vehicles and without payment of the regular  
 98 license fee for plates as prescribed under Article 7 of this chapter, such veteran shall be  
 99 issued similar license plates as prescribed in Code Section 40-2-71 for private passenger

100 cars. There shall be no charge for the additional plate issued such veteran under this Code  
 101 section. There shall be no charge for revalidation decals for such plates.

102 (c) If a veteran has not been certified as disabled by the United States Department of  
 103 Veterans Affairs, such veteran may submit to the Department of Veterans Service such  
 104 veteran's discharge papers and a certified statement from a physician, licensed under  
 105 Chapter 34 of Title 43, certifying that in the opinion of such physician such veteran is  
 106 disabled to a degree enumerated in Code Section 40-2-69. If the certificate from the  
 107 physician indicates the qualifying disabilities which meet the standards of the United States  
 108 Department of Veterans Affairs, the commissioner of veterans service shall submit a letter  
 109 to the state revenue commissioner indicating that the veteran meets the requirements of this  
 110 Code section and qualifies for a special license plate as provided in this Code section."

### 111 SECTION 3.

112 Said article is further amended by revising Code Section 40-2-71, relating to design of  
 113 disabled veteran plates and restrictions on issuance and transfer, as follows:

114 "40-2-71.

115 (a) The commissioner is directed to furnish the license plates provided for in Code  
 116 Sections 40-2-69 and 40-2-70. Such plates shall be printed in three colors: red, white, and  
 117 blue. The commissioner is authorized and directed to design the license plate. Each plate  
 118 shall contain, in bold characters, the name of the state, or abbreviation thereof, the year, the  
 119 serial number, ~~and~~ either the words 'Disabled Veteran' or 'Disabled Vet.' Vet,' and an image  
 120 of the International Symbol of Access which is at least one inch in height and is white on  
 121 a blue background.

122 (b) Such license plates so issued shall be transferred to another vehicle as provided in  
 123 Code Section 40-2-80.

124 (c) No disabled veteran shall be entitled to own or operate more than one vehicle with the  
 125 free license plates provided by Code Sections 40-2-69, 40-2-70, and this Code section."

### 126 SECTION 4.

127 Said article is further amended by revising subsection (a) of Code Section 40-2-84, relating  
 128 to the issuance of license plates to veterans awarded Purple Hearts, as follows:

129 "(a)(1) Motor vehicle or motorcycle owners who are veterans of the armed forces of the  
 130 United States who have been awarded the Purple Heart citation shall be eligible to receive  
 131 a special and distinctive vehicle license plate for a private passenger car, motorcycle,  
 132 trailer, or truck used for personal transportation, provided that the requisite number of  
 133 applications ~~are~~ is received by the commissioner as provided in subsection (b) of this  
 134 Code section. Such license plate shall be issued in compliance with the state motor

135 vehicle laws relating to registration and licensing of motor vehicles as prescribed in  
136 Article 2 of this chapter.

137 (2) For purposes of this Code section, the term 'veteran' shall include a member of the  
138 armed forces or reserves who is still serving on active duty after being awarded the  
139 Purple Heart citation."

140 **SECTION 5.**

141 Said article is further amended by revising Code Section 40-2-85.1, relating to special and  
142 distinctive license plates for veterans, as follows:

143 "40-2-85.1.

144 (a) For purposes of this Code section, the term:

145 (1) 'Military medal award' means the following medals, decorations, or other recognition  
146 of honor for military service awarded by a branch of the United States military:

147 (A) Medal of Honor;

148 (B) Bronze Star Medal;

149 (C) Silver Star Medal;

150 (D) Distinguished Service Cross;

151 (E) Navy Cross;

152 (F) Air Force Cross;

153 (G) Defense Distinguished Service Medal;

154 (H) Homeland Security Distinguished Service Medal;

155 (I) Distinguished Service Medal;

156 (J) Navy Distinguished Service Medal;

157 (K) Air Force Distinguished Service Medal;

158 (L) Coast Guard Distinguished Service Medal;

159 (M) Defense Superior Service Medal;

160 (N) Legion of Merit;

161 (O) Distinguished Flying Cross;

162 (P) Purple Heart; and

163 (Q) Air Medal.

164 (2) 'Served during active military combat' means active duty service in World War I,  
165 World War II, the Korean War, the Vietnam War, Operation Desert Storm, the Global  
166 War on Terrorism as defined by Presidential Executive Order 13289, Section 2, the war  
167 in Afghanistan, or the war in Iraq, which includes either Operation Iraqi Freedom or  
168 Operation Enduring Freedom.

169 (b)(1) Motor vehicle and trailer owners who are retired veterans of the armed forces of  
170 the United States, or who have received a military medal award, or persons who served

171 during active military combat ~~World War I, World War II, the Korean War, the Vietnam~~  
 172 ~~War, or Operation Desert Storm~~ shall be eligible to receive special and distinctive vehicle  
 173 license plates for private passenger cars, trucks, or recreational vehicles used for personal  
 174 transportation. Eligibility to receive a special and distinctive vehicle license plate for  
 175 persons who are no longer serving in the United States military shall be conditioned on  
 176 such person having been discharged from military service under honorable conditions.  
 177 Such license plates shall be issued in compliance with the state motor vehicle laws  
 178 relating to registration and licensing of motor vehicles as prescribed in Article 2 of this  
 179 chapter.

180 (2)(A) Motor vehicle and trailer owners who retired from active duty with the armed  
 181 forces of the United States or have received a military medal award or served during  
 182 active military combat shall be issued upon application for and upon compliance with  
 183 the state motor vehicle laws relating to registration and licensing of motor vehicles a  
 184 retired veteran's license plate, military medal award recipient license plate, or  
 185 commemorative service license plate for service during active military combat. One  
 186 such ~~retired veteran's~~ license plate shall be issued without the requisite registration fee,  
 187 manufacturing fee, or annual registration fee.

188 (B) Each ~~retired member~~ or former member of the armed forces listed in subsection (b)  
 189 of this Code section shall be entitled to no more than one such free license plate at a  
 190 time; provided, however, that upon payment of a manufacturing fee of \$25.00, a  
 191 member shall be entitled to one additional such license plate. For each additional  
 192 license plate for which a \$25.00 manufacturing fee is required, there shall be an  
 193 additional annual registration fee of \$25.00 which fee shall be collected by the county  
 194 tag agent at the time of collection of other registration fees and shall be remitted to the  
 195 state as provided in Code Section 40-2-34.

196 ~~(b)(c)~~ The commissioner shall design a retired veteran's license plate, a military medal  
 197 award recipient license plate, and ~~or a distinctive~~ license plate to commemorate service ~~by~~  
 198 ~~with~~ the United States armed forces ~~in wars~~ during active military combat ~~listed in~~  
 199 ~~subsection (a) of this Code section.~~ The commissioner shall promulgate such rules and  
 200 regulations as may be necessary to enforce compliance with all state license laws relating  
 201 to the use and operation of private passenger cars, ~~and trucks, and trailers~~ before issuing  
 202 these license plates in lieu of the regular Georgia license plates. The manufacturing fee for  
 203 such special and distinctive license plates shall be \$25.00. The commissioner is  
 204 specifically authorized to promulgate all rules and regulations necessary to ensure  
 205 compliance in instances where such vehicles have been transferred or sold. Except as  
 206 provided in subsection (d) of this Code section, such plates shall be nontransferable.

207 ~~(e)~~(d) The special and distinctive vehicle license plates shall be as prescribed in Article 2  
 208 of this chapter for private passenger cars, ~~and trucks, and trailers~~ used for personal  
 209 transportation. Such plates shall contain such words or symbols, in addition to the numbers  
 210 and letters prescribed by law, so as to identify distinctively the owners as retired veterans  
 211 of the armed forces of the United States, or recipients of a military medal award, or persons  
 212 who served during active military combat ~~World War I, World War II, the Korean War, the~~  
 213 ~~Vietnam War, or Operation Desert Storm~~ and shall additionally, for such plates  
 214 manufactured after July 1, 2001, identify distinctly the owner as a veteran of one of the  
 215 following branches of the armed forces: Army, Navy, Marines, Air Force, or Coast Guard.  
 216 ~~(d)~~(e) The license plate issued pursuant to this Code section shall be transferred between  
 217 vehicles as provided in Code Section 40-2-80. The spouse of a deceased ~~retired~~ veteran  
 218 of the armed forces of the United States or of a deceased person who received a military  
 219 medal award or who served during active military combat ~~World War I, World War II, the~~  
 220 ~~Korean War, the Vietnam War, or Operation Desert Storm~~ shall continue to be eligible to  
 221 be issued a distinctive personalized license plate as provided in this Code section for any  
 222 vehicle owned by such veteran ownership of which is transferred to the surviving spouse  
 223 or for any other vehicle owned by such surviving spouse either at the time of the qualifying  
 224 veteran's death or acquired thereafter, so long as such person does not remarry.  
 225 ~~(e)~~(f) Special license plates issued under this Code section, except as provided in  
 226 subparagraph (a)(2)(A) of this Code section, shall be renewed annually with a revalidation  
 227 decal as provided in Code Section 40-2-31 without payment of an additional \$25.00 annual  
 228 registration fee. It shall be a requirement that a county name decal shall be affixed and  
 229 displayed on license plates issued under this Code section."

230 **SECTION 6.**

231 Said article is further amended by revising paragraph (2) of subsection (a) and by adding  
 232 three new paragraphs to subsection (m) of Code Section 40-2-86, relating to special license  
 233 plates promoting certain beneficial projects and supporting certain worthy agencies, funds,  
 234 or nonprofit corporations, to read as follows:

235 "(2) In accordance with Article III, Section IX, Paragraph VI(n) of the Constitution, the  
 236 General Assembly has determined that the issuance of special license plates to support  
 237 an agency or fund or a program beneficial to the people of this state that is administered  
 238 by a nonprofit corporation organized under Section 501(c)(3) of Title 26 of the Internal  
 239 Revenue Code and dedicating a portion of the funds raised from the sale of these special  
 240 license plates is in the best interests of the people of this state. ~~Any new special license~~  
 241 ~~plates adopted on or after July 1, 2010, that share a portion of the revenue raised with any~~

242 ~~agency, fund, nonprofit organization, or other similar entity shall allocate the revenue in~~  
 243 ~~accordance with the formula contained in subsection (l) of this Code section."~~

244 "(10) A special license plate to support prostate cancer related awareness and research  
 245 programs. The provisions of paragraph (1) of this subsection notwithstanding, from the  
 246 additional \$35.00 special license plate fee or special license plate renewal fee charged for  
 247 the issuance and renewal of prostate cancer license plates authorized under this  
 248 paragraph, \$13.00 shall be deposited in the general fund and \$22.00 shall be disbursed  
 249 to the Georgia Prostate Cancer Coalition to fund prostate cancer awareness, research,  
 250 screening, and treatment related programs.

251 (11) A special license plate to support lung cancer related awareness and research  
 252 programs. The funds raised by the sale of this special license plate shall be disbursed as  
 253 provided in paragraph (1) of this subsection to the Joan Gaeta Lung Cancer Fund to fund  
 254 lung cancer awareness, screening, research, and treatment related programs.

255 (12) A special license plate to support Georgia nurses and charitable and philanthropic  
 256 efforts to support, advance, and promote the nursing profession. The funds raised by the  
 257 sale of this special license plate shall be disbursed as provided in paragraph (1) of this  
 258 subsection to the Georgia Nurses Foundation of the Georgia Nurses Association for  
 259 carrying out such programs and purposes."

260 **SECTION 7.**

261 Said article is further amended by revising subsection (d) of Code Section 40-2-86.1, relating  
 262 to special license plates promoting certain beneficial projects and supporting certain worthy  
 263 agencies, funds, or nonprofit corporations, as follows:

264 "(d) Any Georgia resident who is the owner of a motor vehicle, except a vehicle registered  
 265 under the International Registration Plan, upon complying with the motor vehicle laws  
 266 relating to registration and licensing of motor vehicles and upon the payment of a  
 267 manufacturing fee of \$25.00 and a special license plate fee of \$35.00, in addition to the  
 268 regular motor vehicle registration fee, shall be able to apply for a special license plate listed  
 269 in subsection (l) of this Code section. Revalidation decals shall be issued for special  
 270 license plates in the same manner as provided for general issue license plates, with the  
 271 addition of a \$35.00 special license plate renewal fee, provided that special license plates  
 272 issued pursuant to paragraph (9) of subsection (l) of this Code section shall be exempt from  
 273 such special license plate renewal fee."

274 **SECTION 8.**

275 All laws and parts of laws in conflict with this Act are repealed.
