A BILL TO BE ENTITLED AN ACT

To amend Part 3 of Article 6 of Chapter 3 of Title 20 of the Official Code of Georgia
Annotated, relating to the Georgia Student Finance Authority, so as to change designations
from North Georgia College to the University of North Georgia; to designate the University
of North Georgia as the senior military college of Georgia; to repeal conflicting laws; and
for other purposes.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

SECTION 1.

8 Part 3 of Article 6 of Chapter 3 of Title 20 of the Official Code of Georgia Annotated,

9 relating to the Georgia Student Finance Authority, is amended by revising Subpart 5A,

10 relating to the University of North Georgia military scholarships, as follows:

"Subpart 5A

12 20-3-420.

13 (a) The General Assembly finds that the University of North Georgia College, a unit of the 14 University System of Georgia, is widely recognized as one of the most outstanding senior 15 military colleges in the United States and that its outstanding status as a senior military college has been formally recognized by the board of regents and by the Department of the 16 17 Army of the United States. The purpose of this subpart is to recognize this status of the 18 <u>University of North Georgia College</u> and to enable Georgia's most gifted young people who 19 are interested in pursuing a military career to attend the this state's premier senior military 20 college under a full scholarship. 21 (b) The General Assembly officially designates the University of North Georgia as the 22 premier senior military college of Georgia.

23 20-3-421.

24 (a) In order for a student to qualify as a nominee for and to be a recipient of a scholarship

25 under this subpart, the student shall meet the following standards and requirements:

- 26 (1) The student shall be a resident of Georgia; 27 (2) The student shall have demonstrated academic excellence at the high school level; 28 (3) The student must shall meet mental and physical health standards required for 29 commission in the Army National Guard; and 30 (4) The student shall qualify for regular admission to the University of North Georgia 31 College. 32 (b) If selected as a recipient of a scholarship under this subpart, a student, in order to 33 maintain eligibility for the scholarship, shall: 34 (1) Maintain standards of academic excellence and standards of conduct as established 35 by the University of North Georgia College; (2) Maintain minimum full-time enrollment of at least 12 hours each quarter; 36 37 (3) Participate in military and Reserve Officers' Training Corps programs at the 38 <u>University of</u> North Georgia College; 39 (4) Maintain membership in good standing in the Army National Guard; 40 (5) Demonstrate the qualities required of a commissioned officer in the United States 41 armed forces; and (6) Upon graduation from the University of North Georgia College, accept a commission 42 43 as a second lieutenant and agree to serve not less than four years in the Georgia Army 44 National Guard; however, terms of the scholarship may be met by acceptance of a 45 commission and active duty service for not less than four years in the United States Army 46 or a combination of service in the active army and the Georgia Army National Guard for 47 not less than four years upon certification by the adjutant general that no need exists in 48 the Georgia Army National Guard at the time of the commencement of the period of 49 active service. 50 (c) No recipient of a scholarship under this subpart shall be eligible to receive financial aid 51 assistance under any other student financial aid program authorized by the laws of this
- 52 state.

53 20-3-422.

The authority shall establish and promulgate, consistent with this subpart, criteria for the eligibility and award of such scholarships. The authority shall, on or before February 1 of each year, select and nominate six persons from each congressional district in Georgia from a list of persons recommended to the authority by members of the General Assembly. From the persons so nominated, three persons from each congressional district shall be selected as scholarship recipients as provided in Code Section 20-3-423.

- 61 (a) For the purpose of considering nominations submitted under Code Section 20-3-422,
- 62 there is created a selection committee, the membership of which shall be as follows:
- (1) The chief executive officer of <u>the University of</u> North Georgia College or his or her
 designated representative, who shall serve as chairperson of the selection committee;
- 65 (2) The professor of military science at <u>the University of North Georgia College</u> or his
 66 or her designated representative;
- 67 (3) The director of admissions of <u>the University of</u> North Georgia College;
- 68 (4) A civilian faculty member of <u>the University of</u> North Georgia College designated by
- 69 the chief executive officer of the college <u>university;</u>
- (5) A commissioned officer of the Army National Guard designated by the adjutantgeneral;
- (6) The chairperson of the House <u>Committee on Higher Education Committee</u> or his or
 her designee from that committee;
- 74 (7) The chairperson of the Senate Higher Education Committee or his or her designee
 75 from that committee; and
- 76 (8) The executive director of the Georgia Student Finance Authority or his or her77 designated representative.
- (b) It shall be the duty of the selection committee to select, from the six nominees from
 each congressional district submitted to the committee pursuant to Code Section 20-3-422,
 three persons from each congressional district to receive a scholarship under this subpart.
- 81 In the event a congressional district does not have three qualified candidates, the committee
- 82 may select a candidate or candidates at large from alternate nominees among the original
- 83 candidates without regard to the congressional district of residence. Upon selecting the
- 84 recipients of scholarships, the committee shall:
- 85 (1) Notify each recipient of the scholarship;
- 86 (2) Notify each member of the legislative delegation from each congressional district of
- 87 the names of the recipients of the scholarships from that congressional district; and
- 88 (3) Notify the authority of the names and addresses of the recipients of the scholarships.
- 89 (c) The selection committee shall have the following additional duties:
- 90 (1) To publish in print or electronically and maintain standards of academic excellence
 91 and conduct necessary for continued eligibility for a scholarship under this subpart; and
- 92 (2) To monitor the performance of the recipients of scholarships under this subpart in
- 93 accordance with the standards promulgated under paragraph (1) of this subsection.

- Scholarship awards made under this subpart shall cover all costs for room, board,
 matriculation, fees, uniform deposits, and an allowance for books and supplies.

- Scholarship assistance may be provided to a recipient under this article for a maximum

period of 12 academic quarters.

99 20-3-425.

(a) If the recipient of a scholarship under this subpart fails to honor his <u>or her</u> obligation
to serve in the Army National Guard or the United States Army as provided in paragraph
(6) of subsection (b) of Code Section 20-3-421, such recipient shall, at the option of the
recipient, either:

- (1) Serve not less than four years as an enlisted member of the Army National Guard orUnited States Army; or
- (2) Pay to the authority an amount equal to the amount of scholarship assistance received
 by the recipient under this subpart, plus interest, such amount to be paid, in accordance
 with regulations of the authority, within five years after the recipient graduates from or
 terminates his <u>or her</u> enrollment in <u>the University of</u> North Georgia College.

110 (b) Subsection (a) of this Code section shall not apply to any person who, for bona fide

- reasons of health as jointly verified by the authority and the selection committee, is unable
- to honor the obligation provided for in paragraph (6) of subsection (b) of Code Section20-3-421.

115 (a) If at any time a recipient of a scholarship fails to meet the standards and requirements 116 for continued eligibility as provided by the selection committee pursuant to subsection (c) of Code Section 20-3-423, such recipient shall thereby lose eligibility for the scholarship 117 and shall be obligated to repay the same as provided in Code Section 20-3-425. The 118 119 selection committee shall promptly notify the authority when a recipient loses eligibility. (b) In the event a scholarship recipient fails to meet the standards for retention or 120 121 otherwise surrenders the scholarship, the committee may select a candidate to fill the vacancy for the remaining period of the scholarship. The nominees shall be required to 122 meet all criteria established for the four-year scholarship. Such recipients of scholarships 123 124 shall incur the same obligations as a four-year scholarship recipient; provided, however, that such recipients of scholarships of less than four years shall only be required to serve 125 the number of years in the Georgia Army National Guard or number of years of active duty 126 service in the United States Army or number of years in a combination of service in the 127 active army and the Georgia Army National Guard which corresponds to the period or 128 number of years of such scholarship. 129

136 Said part is further amended by revising Subpart 6, relating to the North Georgia College

137Reserve Officers' Training Corps grant program, as follows:

"Subpart 6

139 20-3-430.

The General Assembly finds that it is essential for the national defense that persons be 140 encouraged to consider military leadership positions as an honorable and rewarding 141 142 profession and that the University of North Georgia College, Georgia's only state supported military college, plays a significant role in preparing and training students for professional 143 144 life in the military as a profession. It is the purpose of the General Assembly, as provided 145 for in this subpart, to encourage students to enroll in the University of North Georgia 146 College and its military training program by providing for tuition grant assistance to such 147 students.

148 20-3-431.

149 For purposes of this subpart, the term 'eligible student' shall mean means a person who:

150 (1) Is enrolled in or accepted for enrollment in <u>the University of</u> North Georgia College

151 for a minimum of 12 academic hours;

- 152 (2) Is or will be a citizen of this state for a period of at least 12 months immediately prior
- to the date of registration therein; and
- (3) Is enrolled in or plans to enroll in the Army Reserve Officers' Training Corps
 program at <u>the University of</u> North Georgia College.

- 157 There is granted to each eligible student attending the University of North Georgia College
 158 the sum of \$500.00 per academic quarter.
- 159 20-3-433.
- 160 Each eligible student wishing to receive the grant provided for in this subpart shall submit
- 161 to <u>the University of North Georgia College</u> an application for the grant payment at the time

and in accordance with procedures prescribed by the authority. The authority is authorized 162 to define such terms and prescribe such rules, regulations, and procedures as may be 163 164 reasonable and necessary to carry out the purposes of this subpart. The authority shall not approve payment of any grant until it has received from an appropriate officer of the 165 University of North Georgia College a certification that the student applying for the grant 166 is an eligible student. Upon timely receipt of such certification, in proper form, the 167 168 authority is authorized to pay the grant to the University of North Georgia College on behalf of and to the credit of the student. In the event a student on whose behalf a grant is 169 170 paid shall does not enroll as a full-time student for the school term for which the grant is paid, the University of North Georgia College shall make a refund to the authority in 171 accordance with regulations of the authority. 172

174 In the event funds available to the authority are not sufficient to enable the authority to pay

175 on behalf of eligible students the full grant prescribed by the General Assembly, grants

payable for the remaining school terms shall be reduced by the authority on a pro rata basis.

177 20-3-435.

178 The University of North Georgia College shall be subject to examination by the state auditor for the sole purpose of determining whether the school has properly certified 179 180 eligibility and enrollment of students and credited grants paid on behalf of such students. 181 However, nothing in this subpart shall be construed to interfere with the authority of the 182 school to determine admissibility of students or to control its own curriculum, philosophy, purpose, or administration. In the event it is determined that the school knowingly or 183 184 through error certified an ineligible student to be eligible for a grant under this subpart, the 185 amount of the grant paid to the school pursuant to such certification shall be refunded by the school to the authority. 186

Any person who knowingly makes or furnishes any false statement or misrepresentation or who accepts such statement or misrepresentation knowing it to be false for the purpose of enabling an ineligible student to obtain wrongfully a grant under this subpart shall be guilty of a misdemeanor."

193 Said part is further amended by revising Subpart 6A, relating to tuition grant assistance for

197 The General Assembly finds that it is essential for the national defense that persons be encouraged to consider military leadership positions as an honorable and rewarding 198 199 profession and that the University of North Georgia College and State University, Georgia's 200 only state supported military college, plays a significant role in preparing and training 201 students for professional life in the military as a profession.  and State University for a minimum of 12 academic hours;

(2) Is or will be a citizen of this state for a period of at least 12 months immediately priorto the date of registration therein;

(3) Is enrolled in or plans to enroll in the Army Reserve Officers' Training Corps
 program at <u>the University of</u> North Georgia College and State University; and

(4) Has signed a contract to accept a commission, to be effective upon graduation, no

- services of the United States or the Army National Guard.

- 218 There is granted to each eligible student attending <u>the University of</u> North Georgia College
- and State University the sum of \$1,500.00 per academic semester.
- 220 20-3-443.

Each eligible student wishing to receive the grant provided for in this subpart shall submit to <u>the University of North Georgia College and State University</u> an application for the grant payment at the time and in accordance with procedures prescribed by the authority. The authority is authorized to define such terms and prescribe such rules, regulations, and procedures as may be reasonable and necessary to carry out the purposes of this subpart. The authority shall not approve payment of any grant until it has received from an appropriate officer of <u>the University of</u> North Georgia College and State University a

certification that the student applying for the grant is an eligible student. Upon timely receipt of such certification, in proper form, the authority is authorized to pay the grant to the University of North Georgia College and State University on behalf of and to the credit of the student. In the event a student on whose behalf a grant is paid shall does not enroll as a full-time student for the school term for which the grant is paid, the University of North Georgia College and State University shall make a refund to the authority in

SECTION 4.

Said part is further amended by revising Code Section 20-3-491, relating to applications forscholarship grants and administration of program, as follows:

257 "20-3-491.

(a) Subject to appropriations by the General Assembly, the authority shall establish a 258 program of two-year scholarship grants for eligible students attending the University of 259 North Georgia College and participating in a Reserve Officers' Training Corps program 260 while so enrolled. Any person meeting the conditions of this subpart may apply to the 261 authority for a grant. Such application shall be submitted in writing on forms prescribed 262 by the authority for such purpose. The applicant shall furnish such information as may be 263 required by the authority for determination of eligibility for the grant. The authority shall 264 approve grant renewals only upon receipt of the recipient's application therefor and upon 265 a finding that the recipient has successfully completed the work of the preceding school 266 period and presents evidence that he or she is a student in good standing, that he or she 267 remains a citizen of this state, and that he or she remains otherwise qualified to receive 268 269 such grant under this subpart. 270 (b) The authority is authorized to prescribe such rules and regulations as may be necessary

271 or convenient for administration of this program and to establish procedures for

272 determination of eligibility of applicants."

SECTION 5.

All laws and parts of laws in conflict with this Act are repealed.
