## A RESOLUTION

- 1 Recognizing Wednesday, February 6, 2013, as Skin Cancer Awareness Day at the state
- 2 capitol; and for other purposes.
- 3 WHEREAS, melanoma and other skin cancers are one of the most preventable, yet fatal,
- 4 forms of cancer, accounting for more than 50 percent of all cancers combined, including
- 5 breast, lung, and prostate cancer; and
- 6 WHEREAS, one American dies of melanoma every 67 minutes, and the estimated total
- 7 direct annual cost of melanoma treatment exceeds \$290 million; and
- 8 WHEREAS, it is reported that of the one million newly diagnosed cases of melanoma and
- 9 other skin cancers each year, an estimated 10,710 people will die; and
- 10 WHEREAS, the objectives of the Georgia Society of Dermatologists are to promote the
- 11 highest possible standards of clinical practice, education, and research in dermatologic
- 12 medicine and surgery and related disciplines; to promote the public interest relating to
- dermatology; to advocate on behalf of dermatology and high-quality patient care; and to
- 14 provide a forum for the discussion of medical and practice related problems; and
- 15 WHEREAS, the Atlanta Dermatological Association is an association of dermatologists
- practicing in the greater Atlanta area, dedicated to promoting the highest possible standards
- of clinical practice, education, and research in dermatologic medicine, surgery, and related
- disciplines while promoting the public interest relating to dermatology and providing a forum
- 19 for the discussion of medical and practice related problems; and
- 20 WHEREAS, the mission of the Skin Cancer Awareness Network Foundation is to create
- 21 public awareness of the dangers of excessive or unprotected direct exposure to the sun or
- both and to educate people about preventive safety measures to avoid or lessen the chances
- 23 of developing melanoma or one of the other preventable skin cancers; and

24 WHEREAS, it is necessary to encourage public awareness of the dangers of excessive or

- 25 unprotected direct exposure to the sun and to educate people about preventive safety
- 26 measures to avoid or lessen the chances of developing melanoma or one of the other
- 27 preventable skin cancers while still being able to safely enjoy outdoor activities.
- NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 29 encourage all Georgians to have a greater awareness of the risks of skin cancer and the need
- 30 for early diagnosis of skin cancer and recognize February 6, 2013, as Skin Cancer Awareness
- 31 Day at the state capitol.
- 32 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
- 33 to transmit appropriate copies of this resolution to the Georgia Society of Dermatologists, the
- 34 Atlanta Dermatological Association, and the Skin Cancer Awareness Network Foundation.
