

Senate Bill 100

A BILL TO BE ENTITLED  
AN ACT

1 To amend Article 2 of Chapter 14 of Title 20 of the Official Code of Georgia Annotated,  
2 relating to education accountability assessment programs, so as to reestablish the Career and  
3 Technical Education Advisory Commission; to provide for membership, filling of vacancies,  
4 terms, officers, duties, meetings, and reimbursement of members of the commission; to  
5 provide for related matters; to repeal conflicting laws; and for other purposes.

6 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

7 **SECTION 1.**

8 Article 2 of Chapter 14 of Title 20 of the Official Code of Georgia Annotated, relating to  
9 education accountability assessment programs, is amended by adding a new part to read as  
10 follows:

11 "Part 9

13 (a) There is created the Career and Technical Education Advisory Commission.

14 (b)(1) The commission shall consist of four members of the House of Representatives  
15 to be appointed by the Speaker of the House, one of whom shall be from the House  
16 Committee on Economic Development and Tourism, one of whom shall be from the  
17 House Committee on Agriculture and Consumer Affairs, one of whom shall be from the  
18 House Committee on Education, and one of whom shall be from the House Committee  
19 on Higher Education; four members of the Senate to be appointed by the President of the  
20 Senate, one of whom shall be from the Senate Economic Development Committee, one  
21 of whom shall be from the Senate Agriculture and Consumer Affairs Committee, one of  
22 whom shall be from the Senate Education and Youth Committee, and one of whom shall  
23 be from the Senate Higher Education Committee; three members who are not members  
24 of the General Assembly to be appointed by the Governor; and three members who are

25 not members of the General Assembly to be appointed by the State School  
26 Superintendent.

27 (2) Vacancies in the commission shall be filled in the same manner as the original  
28 appointments.

29 (3)(A) Legislative members of the commission shall serve two-year terms concurrent  
30 with their terms as members of the General Assembly.

31 (B) Nonlegislative members of the commission shall serve for two-year terms  
32 concurrent with those terms of legislative members of the commission.

33 (c) The Speaker of the House shall designate one of the commission members from the  
34 House of Representatives as a co-chairperson of the commission, and the President of the  
35 Senate shall designate one of the commission members from the Senate as a co-chairperson  
36 of the commission. Each co-chairperson shall serve as such concurrent with his or her term  
37 as a member of the commission.

38 (d)(1) The head of the career and technical education program of the Department of  
39 Education shall report annually to the commission regarding the conditions, needs, issues,  
40 and problems of the program.

41 (2) The commission shall periodically review the conditions, needs, issues, and problems  
42 related to the career and technical education program, issue annually a report on the same  
43 to the General Assembly, and recommend any action or legislation which the commission  
44 deems necessary or appropriate.

45 (e)(1) The commission may conduct such meetings at such places and at such times as  
46 it may deem necessary or convenient to enable it to exercise fully and effectively its  
47 powers, perform its duties, and accomplish the objectives and purposes of this Code  
48 section. The commission shall meet upon the call of either co-chairperson. The  
49 commission shall meet at least once but not more than four times annually.

50 (2) The legislative members of the commission shall receive the allowances provided for  
51 in Code Section 28-1-8. Any citizen members shall receive a daily expense allowance  
52 in the amount specified in subsection (b) of Code Section 45-7-21 as well as the mileage  
53 or transportation allowance authorized for state employees. Any members of the  
54 commission who are state officials, other than legislative members, and state employees  
55 shall receive no compensation for their services on the commission, but they shall be  
56 reimbursed for expenses incurred by them in the performance of their duties as members  
57 of the commission in the same manner as they are reimbursed for expenses in their  
58 capacities as state officials or employees. The funds necessary for the reimbursement of  
59 the expenses of state officials, other than legislative members, and state employees shall  
60 come from funds appropriated to or otherwise available to the Department of Education.  
61 All other funds necessary to carry out the provisions of this Code section shall come from

62 funds appropriated to the House of Representatives and the Senate. The expenses and  
63 allowances authorized by this paragraph shall not be received by members of the  
64 commission for more than four days annually."

65 **SECTION 2.**

66 All laws and parts of laws in conflict with this Act are repealed.
