

House Bill 273

A BILL TO BE ENTITLED
AN ACT

1 To amend an Act establishing the State Court of Bibb County, formerly the City Court of
2 Macon, approved August 14, 1885 (Ga. L. 1884-85, p. 470), as amended, so as to provide
3 an additional judge for said court; to provide for the initial appointment of such additional
4 judge by the Governor; to provide for the election and terms of office for the judges of said
5 court; to provide for a chief judge of said court; to provide for the compensation of the judges
6 of said court; to provide for the selection, terms of office, and compensation of the
7 solicitor-general of said court; to provide for related matters; to repeal conflicting laws; and
8 for other purposes.

9 BE IT ENACTED BY THE GENERAL ASSEMBLY OF GEORGIA:

10 style="text-align:center">**SECTION 1.**

11 An Act establishing the State Court of Bibb County, formerly the City Court of Macon,
12 approved August 14, 1885 (Ga. L. 1884-85, p. 470), as amended, is amended by revising
13 Sections IV, V, and VI as follows:

14 style="text-align:center">"SECTION IV.

15 (a) There shall be two full-time judges of the State Court of Bibb County who shall be
16 selected as provided in this section.

17 (b) The judge of the State Court of Bibb County in office on January 1, 2013, shall
18 continue to serve the term of office to which said judge was elected until the election and
19 qualification of a successor as provided by law.

20 (c) The additional judge appointed as provided by this Act shall be appointed by the
21 Governor for a term beginning July 1, 2013, and expiring December 31, 2014, and until a
22 successor is elected and qualified. A successor to the additional judge shall be elected in
23 a manner provided by Code Section 21-2-138, of the O.C.G.A. for the election of judges
24 of the state courts of this state in 2014 for a term of four years beginning on January 1,
25 2015, and until the election and qualification of a successor. Future successors shall be

26 elected each four years thereafter as provided by Code Section 21-2-138 of the O.C.G.A.
27 for terms of four years and until the election and qualification of a successor. They shall
28 take office on the first day of January following the date of the election. Such elections
29 shall be held and conducted in a manner provided by law for the election of judges of the
30 state courts of this state.

31 (d) The judge of the State Court of Bibb County having the longest time in service as a
32 judge of said court shall be the chief judge of the State Court of Bibb County with such
33 powers and responsibilities as provided by law.

34 (e) The judges of the State Court of Bibb County shall receive as salary compensation an
35 amount equal to 90 percent of the base salary paid to a judge in the superior courts by the
36 state and, in addition, an amount equal to any county supplement paid to judges of the
37 Superior Court of Bibb County. The chief judge of the State Court of Bibb County shall
38 also be paid additional salary compensation in the amount of \$2,500.00. All of such
39 compensation shall be paid from the funds of Bibb County and in like intervals and
40 installments as salaries are paid to employees of Bibb County. In addition to the salary
41 compensation provided for in this section, the governing authority of Bibb County shall
42 pay on behalf of each judge of the State Court of Bibb County a sum equal to the
43 contribution required for judges by the Georgia Judicial Retirement System created by
44 Chapter 23 of Title 47 of the O.C.G.A.

45 **SECTION V.**

46 The judges of the State Court of Bibb County shall have such qualifications, powers, and
47 authority, and shall be subject to such restrictions and discipline, as provided by Chapter 7
48 of Title 15 of the O.C.G.A. for state court judges in the State of Georgia.

49 **SECTION VI.**

50 The solicitor-general of the State Court of Bibb County shall have such qualifications,
51 powers, and authority, and shall be selected, as provided for by law for solicitors-general in
52 the State of Georgia. The solicitor-general of said court shall receive as compensation an
53 amount equal to 76 percent of the salary of the judges of the Superior Court of Bibb County
54 paid by the state, and, in addition, an amount equal to the amount of any county supplement
55 paid to the judges of the Superior Court of Bibb County. All of such compensation shall be
56 paid from the funds of Bibb County and in like intervals and installments as salaries are paid
57 to employees of Bibb County."

58 **SECTION 2.**

59 All laws and parts of laws in conflict with this Act are repealed.
