A RESOLUTION

1 Recognizing and commending Dr. Jennifer Kelly and inviting her to be recognized by the
2 House of Representatives; and for other purposes.

3 WHEREAS, Jennifer Kelly, Ph.D., ABPP, has diligently and conscientiously devoted
4 innumerable hours of her time and energy toward the betterment of her community and state
5 as evidenced dramatically by her superlative service with the American Psychological
6 Association (APA) and in the Georgia psychology field; and

7 WHEREAS, Dr. Kelly, a licensed psychologist and board certified clinical health
8 psychologist, was recently elected to be the Recording Secretary for the APA; and

9 WHEREAS, while serving as the director of the Atlanta Center for Behavioral Medicine and
10 on the Board of Directors of the APA, Dr. Kelly maintains an independent practice; and

11 WHEREAS, a woman with a keen sensitivity to the needs of the citizens of this state, Dr.
12 Kelly has served as a past president of the Georgia Psychological Association (GPA) and as

15 WHEREAS, in recognition of her dedicated service and advocacy work, Dr. Kelly has
16 received the APA's State Leadership Award, the Federal Advocacy Award of the Practice
17 Organization of the APA, the Karl F. Heiser Advocacy Award, the GPA's Legislative
18 Advocacy Award, the 2006 Outstanding Psychologist Award from Division 31 of the APA,
19 the 2011 Diversity Award from the Committee of State Leaders of the APA, and the 2012
20 APA Division of Health Psychology/American Psychological Foundation Timothy B. Jeffrey
21 Award for Outstanding Contributions to Clinical Health Psychology; and

22 WHEREAS, it is abundantly fitting and proper that the vision and unyielding commitment
23 of this remarkable and distinguished Georgian be appropriately recognized.
