A RESOLUTION

- 1 Recognizing and commending the Fulton County Marshal's Department on the one
- 2 hundredth anniversary of its establishment; and for other purposes.
- 3 WHEREAS, the Fulton County Marshal's Department was established by an act of the
- 4 Georgia General Assembly approved on August 20, 1913; and
- 5 WHEREAS, the Fulton County Marshal's Department was created as part of a larger effort
- 6 to reform and improve the administration of justice in Georgia's urban centers and this effort
- 7 was championed by State Senator Walter McElreath; and
- 8 WHEREAS, the Fulton County Marshal's Department began operations as the Marshal's
- 9 Office of the Fulton Section of the Municipal Court of Atlanta on January 1, 1914; and
- 10 WHEREAS, the Fulton Section of the Municipal Court of Atlanta was redesignated as the
- 11 Civil Court of Fulton County, and ultimately as the State Court of Fulton County; and
- 12 WHEREAS, the Fulton County Marshal's Department currently serves the State Court of
- 13 Fulton County; and
- 14 WHEREAS, the Marshal and Deputy Marshals of the Fulton County Marshal's Department
- 15 are peace officers vested with the "duties, powers, rights, authority, and liabilities...
- 16 prescribed by law for the sheriffs of the several counties...;" and
- 17 WHEREAS, throughout its history, the members of the Fulton County Marshal's Department
- 18 have selflessly sacrificed for the good of the communities that they serve, and on December
- 19 28, 1977, Deputy Marshal David Larry Folds made the supreme sacrifice in the line of duty;

- 21 WHEREAS, the members of the Fulton County Marshal's Department have continually
- 22 demonstrated a commitment to excellence and the Fulton County Marshal's Department is
- 23 the only marshal's department nationally accredited by the Commission on Accreditation for S. R. 279

24 Law Enforcement Agencies Inc., and the Fulton County Marshal's Department has

- 25 maintained national accreditation since 1995; and
- 26 WHEREAS, the members of the Fulton County Marshal's Department continue to exemplify
- 27 the highest traditions of public service and professionalism in law enforcement; and
- 28 WHEREAS, the Fulton County Marshal's Department will celebrate the centennial of its
- 29 establishment on August 20, 2013.
- 30 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
- 31 recognize the centenary of the Fulton County Marshal's Department and commend the past
- 32 and present members of the Fulton County Marshal's Department on their integrity,
- 33 commitment, and competence.
- 34 BE IT FURTHER RESOLVED THAT the Secretary of the Senate is authorized and directed
- 35 to transmit an appropriate copy of this resolution to the Chief Judge of the State Court of
