

Senate Resolution 201

ADOPTED SENATE

A RESOLUTION

- 1 Requesting that the Department of the Army (DA) carefully consider the socioeconomic
- 2 impact the Programmatic Environmental Assessment (PEA) for Army 2020 Force
- 3 Restructuring will have on Fort Benning, Georgia, and the surrounding region; and for other
- 4 purposes.
- 5 WHEREAS, the Programmatic Environmental Assessment (PEA) for Army 2020 Force
- 6 Restructuring included two alternatives for reduction of both active duty and civilian
- 7 personnel at Fort Benning, Georgia, one of which is to take no action and face the loss of
- 8 7,100 personnel and the devastating impact this reduction would have on the region; and
- 9 WHEREAS, the Department of Defense and the Department of the Army have made
- 10 significant investments in the infrastructure of Fort Benning, including \$3.5 billion in
- 11 infrastructure construction, refurbishment, and modernization of facilities to relocate the
- 12 Armor School and other organizations to create the Maneuver Center of Excellence; a new
- 13 75 bed, 750,000 square foot, Martin Army Community Hospital, estimated to cost \$300
- 14 million; and approximately 20,000 acres reshaped; and
- 15 WHEREAS, the federal, state, and local governments, as well as local educational
- 16 authorities, have made significant investments that include a \$57 million interchange into
- 17 Fort Benning; a \$70 million expansion of I-185 from four to six lanes leading into Fort
- 18 Benning's main entrance; the passage of an educational special purpose local option sales tax,
- 19 projected to raise \$223 million to provide for additional schools for the children of soldiers,
- 20 civilian personnel, and defense contractors relocating in the region; and the passage of a
- 21 transportation special purpose local option sales tax to build road infrastructure; and
- 22 WHEREAS, according to the Assessment, a reduction of 7,100 active duty and civilian
- 23 personnel would result in a 17,815 loss in total population, which represents a 5.74 percent
- 24 decrease in the region, a 3.16 percent loss of sales volume, a 4.99 percent drop in regional

25 income, and 5.94 percent loss in regional nonfarm employment, which has the potential to
26 affect low-income populations the most negatively; and

27 WHEREAS, it is the responsibility of all members of the General Assembly to guard
28 diligently the economic, social, and progressive prosperity of citizens throughout the State
29 of Georgia.

30 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE that the members of this body
31 request that the Department of the Army consider the potential repercussions of the
32 Programmatic Environmental Assessment for Army 2020 Force Restructuring, particularly
33 on the economic stability of the region which has been so proud to flourish with the
34 thousands of Fort Benning residents who have called it home.

35 BE IT FURTHER RESOLVED that the Secretary of the Senate is authorized and directed
36 to transmit an appropriate copy of this resolution to the Department of the Army and the
37 United States Army Environmental Command.
